Satish Sharma unveils vision for cyber-secure J&K

NEW DELHI: Minister for Food, Civil Supplies & Consumer Affairs, Satish Sharma on Wednesday said that Jammu & Kashmir is experiencing a "new digital dawn" where technology is empowering citizens, transforming governance, and securing the region's digital future.

Speaking at the India Mobile Congress and the Round Table Conference of State IT Ministers, inaugurated by Union TTMinister Jyotiraditya Scindia, Sharma emphasized that digital initiatives in J&K are not just about expanding telecom infrastructure but creating an inclusive and secure society. "Digital connectivity today is not a privilege but a necessity. It carries education to students in Kupwara, healthcare to patients in Poonch, and opportunities to artisans in Anantnag," he stated.

Highlighting major digital transformation under the Amended BharatNet Project, the Minister shared that highspeed Optical Fibre Cable is being laid to connect 4,299 Gram Panchayats and 2,574 villages

BSNL is also extending Fiber-to-the-Home (FTTH) connections to 2,234 government schools and 1,138 pub lic health centres in rural areas, facilitating e-learning and telemedicine.

To bridge digital gaps, new mobile towers are being installed in remote and border areas. Preparations are also underway for the 5G rollout in urban centres, which will accelerate innovation, entrepreneur-

ship, and smart governance. Emphasizing digital safety, Sharma said the Cyber Security Policy 2022, developed with MeitY and MHA, provides a strong framework for cyber resilience.

He noted that Cyber Police recovered over Rs 4.7 crore from online frauds in 2024 through the National Cyber Crime Reporting Portal. The deployment of Cyber Commandos and the appointment of 183 CISOs and ISOs across departments further bolsters cyber protection.

A Cyber Multi-Agency Centre and a Security Operations Centre (SOC) are operational, while a Mini SOC is being developed at NIC NOC. Additionally, a committee has been formed for the transition to IPv6, ensuring technological readiness

To enhance digital hygiene, strict guidelines have been issued mandating official email usage and disabling unauthorized USB access. The government is also promoting secure platforms like GOV Drive and implementing protocols for virtual communication.
