BRICS adopts new counter-terror strategy; Modi says nations supporting terrorists should be held guilty

NEW DELHI: The fivenation grouping BRICS on Tuesday adopted a new counter-terrorism strategy to effectively deal with the menace, as Prime Minister Narendra Modi asserted that there is a need to ensure that countries supporting terrorists are held guilty, a call backed by Russian president Vladimir Putin, who dubbed such nations "black sheep of the family".

Modi, while addressing the 12th BRICS (Brazil-Russia-India-China-South Africa) summit, held virtually, said terrorism is the "biggest problem" the world is facing, and needed to be dealt with in an organised manner.

At the summit, which was also attended by Chinese President Xi Jinping, Brazilian President Jair Bolsonaro and South African President Cyril Ramaphosa, the Prime Minister talked about the "crisis" facing multilateralism, and highlighted the need for reform of the United Nations Security Council as well as various

revoked Jammu and Kashmir's special status under Article 370 on August 5 last year and bifurcated the state into the union territories of Jammu and Kashmir, and Ladakh. The Congress and the PAGD have a seat sharing arrangement in some places.

The minister said Jammu and Kashmir was, is and will always be an integral part of India and the people of the country will no longer tolerate an "unholy global gathbandhan" against India's national interest.

"Either the Gupkar Gang swims along with the national mood or else the people will sink it," he said.

The home minister also questioned Congress leaders Sonia Gandhi and Rahul Gandhi on whether they support

clear to the people of India," he said. Hitting back, the Congress said it strongly refutes his "concocted and baseless" assertions. In a two-page statement posted on Twitter, its chief spokesperson Randeep Surjewala accused Shah of making mischievous statements on Jammu and Kashmir.

The Congress was never in favour of international intervention on Kashmir issue and was committed to the country's integrity, sovereignty and the tricolour, he said.

"Maybe Amit Shah and the Modi government need a new lesson on nationalism because their parental organisation, RSS, did not hoist the tricolour for 52 years after independence at its headquarters," he said.



Storage of Pfizer's COVID vaccine challenge for most nations; India examining possibilities: Govt

NEW DELHI: The coldchain requirement for the anti-coronavirus vaccine candidate developed by Pfizer at a temperature of minus 70 degrees Celsius poses a big challenge, but the government is examining the possibilities if at all the vaccine has to be obtained by India, it said on Tuesday.

The government further said a national scheme on COVID-19 vaccine distribution is in its final stages of preparation.

At a press briefing, NITI Aayog member (Health) Dr V K Paul, who also heads the National Task Force on COVID-19, said sufficient doses of the vaccine, as required for the Indian population, will not be available, but the government is looking at the possibilities and will work out a strategy for its procurement and distribution in case it gets the reg-

ulatory approvals. Paul, however, reminded that the arrival of the Pfizer vaccine in the country might

take some months.

"The arrangement of coldchains for storing the vaccine developed by Pfizer at a low temperature of minus 70 degrees Celsius is a big challenge and it will not be easy for any nation. But then, if at all it has to be obtained, we are examining what we need to do ... and will work out a strategy," he said.

As for both the vaccine candidates of Moderna and Pfizer, Paul said, "We are watching the

NEW DELHI: In a sharply worded cryptic rejoinder to Gupkar Alliance partners, Union Minister, Dr Jitendra Singh said here on Tuesday that "King" parties had held Jammu & Kashmir to ransom for half a century as dynastic entitlement.

Pertinent to mention that, earlier in the day, National Conference Vice President Omar Abdullah had, in a Tweet, sought to rebut Home Minister Amit Shah who, this morning, posted a series of Tweets denouncing what he described as the Gupkar



Gang.

Omar Abdullah wrote "I can understand the frustration behind this attack by the Hon'ble Home Minister. He had been briefed that the People's Alliance was preparing to boycott elections. This would have allowed the BJP and newly formed King's Party a free run in Jammu & Kashmir. We didn't oblige them". In a prompt and word by

word sarcastic response, Dr Jitendra Singh in the same tone replied, "I can understand the frustration behind the misventure by the Gupkar Gang to gang up against "Shah" because he had spelt the doom of "King" parties, which had for half a century held Jammu & Kashmir to ransom as a

dynastic entitlement". Later, in an interview to a national TV channel, Dr Jitendra alleged that both the Congress and the National Conference (NC) are beating about the bush and trying to evade the moot point as to whether they would restore Article 370, if ever voted to power.

Cornered by Amit Shah, Congress ditches Gupkar Alliance NC loses Dooru, Shangas to Congress without contesting

JAMMU: Cutting teeth with the valleybased alliance of the regional parties for contesting the District Development Council (DDC) elections in a seat-sharing arrangement, Congress has been cornered by the Union Home Minister Amit Shah and forced to sever its bonhomie with Farooq Abdullah-led Peoples Alliance for Gupkar Declaration (PAGD).

"The Gupkar Gang is going global! They want foreign forces to intervene in Jammu and Kashmir. The Gupkar Gang also insults India's Tricolour. Do Sonia Ji and Rahul Ji support such moves of the Gupkar Gang? They should make their stand crystal clear to the people of India", Home Minister Shah tweeted at 1:03 pm on Tuesday. He addressed the valley-based alliance as the "Gupkar Gang".

"Congress and the Gupkar Gang want to take J&K back to the era of terror and turmoil. They want to take away rights of

Dalits, women and tribals that we have ensured by removing Article 370. This is why they're being rejected by the people everywhere", Shah tweeted while mounting a frontal attack on Sonia Gandhi's

"Jammu and Kashmir has been, is and will always remain an integral part of India. Indian people will no longer tolerate an unholy 'global gathbandhan' against our national interest. Either the Gupkar Gang swims along with the national mood or else the people will sink it", Shah tweeted, asserting firmly that J&K would always remain an integral part of India.

Jammu and Kashmir Pradesh Congress Committee (JKPCC) had initially owned up its association with the PAGD which is struggling for restoration of Article 370 and 35-A, besides Statehood, rescinded by the BJP government at the Centre in August 2019. However, apparently for fear of electoral losses, Congress remained

silent and did not attend the PAGD meetings during the course of the Bihar Assembly elections. Immediately after the results came out in Bihar, in favour of the BJP-led alliance, J&K Congress leaders began asserting publicly that their party was part of the PAGD and contesting the DDC elections in a seat-sharing.

Even Farooq Abdullah claimed on more than one occasion that Congress was a part of the PAGD.

Shah's attack on Congress came at an unexpected time as neither the Congress nor the BJP were currently fighting any elections across the country.

Landing in an embarrassing situation, Congress on Tuesday lost no time to start a damage control exercise. It immediately issued a statement in Srinagar and Jammu claiming that it was never part of the PAGD. In the statement, Congress strongly refuted what it called "the baseless allegations levelled by Union Home

Minister Amit Shah".

"(Congress) was neither part of PAGD nor have participated in any of its meetings or deliberations, but it has entered seat sharing at certain places at local district level", said the party statement.
"Congress strongly condemned the propaganda and allegations of Amit shah and urged the latter to refrain from doing such dirty politics.

The party further said that BJP leaders were "in habit of indulging in rumour mongering aiming to gain political mileage". "Eyeing on DDC elections in J&K, Union Home Minister seems desperate enough about the poll outcome, which is certainly going to be unfavourable to BJP", said the Congress statement.

However, the Congress statement of not being part of the PAGD created an embarrassing situation not only for the Farooqled alliance but also for the National Conference (NC) that lost the two DDC seats of Dooru and Shangas in Anantnag district to Congress without contesting.

Monday, 16 November being the last day of filing nomination papers in Phase-II of the DDC elections, J&K PCC President Ghulam Ahmad Mir's son Naseer Ahmad Mir filed his papers from Dooru in a seat sharing arrangement with the PAGD. The decision to leave Dooru and Shangas for Congress left two of NC's strong aspirants disappointed-reportedly angry-in Dooru and NC's former Assembly candidate advocate Riyaz Ahmad Khan in Shahngas.

In Shangas, former Congress MLA Gulzar Khan's daughter Saba Gulzar filed the nomination papers on Monday on behalf of the PAGD. As the Congress declared to move out of the PAGD, no other party can now file nomination papers from Dooru or Shangas where the fight will be straightly between the Congress and the BJP.
