JAMMU: Director Animal Husbandry Jammu Dr. Sagar D. Doifode on Monday visited Jammu and Kashmir Milk Producers Cooperative Limited (JKMPCL) Milk

Plant at Satwari, Jammu and interacted with the management there.

During his visit, the Director thoroughly examined the milk processing infrastructure and its various units including Paneer making unit, Ghee making unit, Curd making unit, Laboratory, Cold storage, Ice cream making unit, Packaging section

The Director was informed by the CEO-JKMPCL that the organi-

zation has an over 10000 membership base of local dairy farmers with linkages to around 400 village Dairy Cooperative Societies and the installed processing capacity of the unit is around one lakh litres of milk per day.

The Director issued on spot instructions to the Chief Animal Husbandry Officer Jammu to organize special exposure visits of the budding dairy entrepreneurs so that the culture of cooperatives is promoted amongst them for their socio-economic betterment. He further added that such visits shall keep them informed and aware of the latest technological advancements in the Dairy Technology industry and facilitate adoption of good management practices in the production & processing of clean milk.

JAMMU: The State Steering Committee (SSC) met here on Monday under the chairmanship of Principal Secretary, Dr Asgar Hassan Samoon, to discuss revision of Institute Development Plans (IDPs) for 32 ITIs under the scheme "Upgradation of 1396 Government ITIs through PPP" besides deliberating on other agenda points of the Committee.

Director Skill Development, Sudershan Kumar, highlighted 'Take it Easy' initiative being launched for students

various issues regarding working of the Committee.

Threadbare discussion was held regarding approval of revision of IDPs of 32 ITIs of JKUT under PPP scheme besides other issues related to upgradation, introduction of

trades and appointment of new Chairmen for ITI Kathua, ITI Kulgam and ITI Bhaderwah.

The SSC approved revision of IDPs of all 32 ITIs, upgradation and introduction of new trades besides deletion of trades as per revised IDP. Besides, appointment of new Chairmen of IMC ITI Kulgam and ITI Kathua was also approved.

The Committee also accorded approval to enhancement in salary of contract instructors at the rate of Rs. 14000 per month with an annual increase of 5%. Besides, revision of ISP of ITI Samba under STRIVE project was also approved.

JAMMU: Directorate of School Education Jammu, in collaboration with UNICEF and NalandaWay Foundation is launching an innovative Programme titled "Take It Easy" for addressing the mental health and well-being needs of adolescents.

The Programme aims to build the socio emotional skills of adolescent boys and girls (aged 13-17 years). The "Take It Easy" project is designed as a 30-day project beginning on 22nd November 2021, one story every day. Students (grades 8 and above) can give a missed call to a number (9266617888). An automated call is placed back to their mobile phones and the story of the day is played. Each story is nearly 5 minutes long. The stories and art activities suggested at the end of every episode help students express their fears, emotions, motivates and support them in learning new positive habits. Students can send their feedback via WhatsApp to this same number or by recording their feedback on the call itself. A set of stories for teachers dealing with adolescents will also be played to help them deal with stress and enhance their wellbeing. This programme will be coordinated by Counselling Cell DSEJ. In this regard, The Chief Education Officers of Jammu Division are directed to publicize this initiative Take it Easy programme in their respective districts by involving District Counselling Coordinators, Zonal Counselling Coordinators, Faculty counselors so as to make its reach to every student. The key action points for promotion and implementation of the initiative are Informing teachers and students about the program via WhatsApp groups of schools and promoting in schools and community classes run by the government (during lockdown); Playing adolescent stories in school assembly and community classes- via the IVRS platform, so that more and more children can hear the content; Ensuring discussion among teachers and students about the stories and activities; Encouraging teacher stories to be heard by the teachers- which will help them to manage themselves and the students they work with.
