## BSG organises webinar on 'The Power of One: The Solidarity of Youth'

NEW DELHI: Only the power and passion of the youth can usher in a new global era of peace and harmony as the world emerges from the scourge of the deadly pandemic, India's youth leaders said on Thursday.

NAGROTA: The protest launched by Jagti Tenement Committee (JTC) and Soan Kashmir Front (SKF) at Jagti Township near Nagrota under the chairmanship of president JTC and SKF, Shadi Lal Pandita entered 412th day on Thursday.

Addressing the protesters, Pandita urged the Government to increase the monthly cash relief of relief holders from Rs 13,000 to Rs 25,000 per family per month.

be built in Kashmir Valley near Baramulla, Srinagar and Anantnag for return and rehabilitation of Kashmiri Pandits.
