He will always be remembered for his amazing zest for life, kindness, helpful nature and unwearing love for his family.

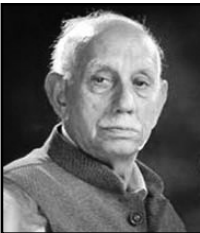
