Subject: Complaint against owner of Vehicle bearing Registration No. JK02BK-7777 (Motor Car, LMV)- Show Cause Notice thereof.

Whereas, this office has received a complaint from Mr. Chita Basu through JK Government Grievances, Jammu vide Grievance ID 999002450615 (copy enclosed);

Whereas, it has been complained that the driver of vehicle bearing Registration No. JK02BK-7777 owned by Sh. Sunil Kumar S/o Sh. Diwan Chand R/o Chak Sardariattar Singh, Mandal, Jammu misbehaved/harassed and also caused inconvenience to him during his Journey from Katra to Pahalgam;

Whereas, it has been found from online 4.0 portal that the above said vehicle is a private Car and unauthorisedly operating for commercial purpose in violation of Section-192A of Motor Vehicles Act, 1988 i.e. without Route Permit and therefore liable to be punished;

Whereas, the violation of Section-192A of Motor Vehicles Act, 1988 by the aforesaid Vehicle operator is prima facie established and warrants punitive action;

Therefore, before taking punitive action against the aforesaid vehicle owner for violation of Section-192A of Motor Vehicles Act, 1988, an opportunity of being heard is given to him to show cause as to why punitive action by way of suspending/cancelling his Registration Certificate shall not be taken for committing aforesaid violation. Your reply shall reach to this office within a period of seven (07) days from the date of issuance of this Show Cause Notice, failing which it shall be presumed that you have nothing to say in your defence and the punitive action (including Cancellation/Suspension of Registration Certificate of your vehicle) shall be taken, without any further notice.
