## Alleged illegal demolition of house: CJM Samba seeks investigation by DIG JKS Range

SAMBAL: In a criminal complaint against the then Deputy Commissioner Samba, SSP, Tehsildar and SHO of concerned area, Chief Judicial Magistrate Samba has sought investigation by DIG Jammu Kathua Samba Range in an alleged illegal demolition of a house. ## 'Special Job creation policy' need of hour & unavoidable: Bhalla

JAMMU: JKPPC Vice President and former Cabinet Minister Raman Bhalla on Thursday claimed that BJP Govt has created such an atmosphere in J&K that people are not able to live peacefully and comfortably.

He said people are in trouble because of BJP Govt's wrong policies.

This was observed by former Minister while interacting with aggrieved people of Gandhi Nagar. He said highest unemployment rate of 21.6 percent recorded in Jammu and Kashmir, which is highest in the country is very serious issue while the country's latest hunger index falling below Pakistan and Bangladesh has shown the failure of the莫夫 Govt's economic policies.

Referring to highest unemployment rate of 21.6, percentage in Jammu and Kashmir as well as country falling in the international hunger index, Bhalla termed it very alarming and a total failure of Modi Government's economic policies.

Pertinent to mention here that the house of complainant was demolished by then DC Samba on February 17, 2020 in Thandi Khui area, opposite Radha Swami Ashram (Vijaypur).

The people are dying of hunger and can't have full stomach meals under Modi Government, which is evident from the survey now. Under Congress led

UPA Government, 27 crores of citizens were brought out of poverty whereas 23 crore people have reportedly slipped into poverty line under BJP regime, reflecting the poorest performance of Modi Government.

Expressing grave concern over the highest unemployment in Jammu and Kashmir in the country, he said that it is the gift of BJP to educated youth of Jammu and Kashmir for seven years.

The unemployed youth of J&K are a neglected and frustrated lot due to wrong policies of the BJP Government.

Bhalla regretted that BJP and Government makes false claims and boast of great achievement in various fronts but their own official surveys prove them wrong and false.

He charged the Government of misleading the people and making false claims whereas the data has proved that Modi

Government has totally failed on economic front.

Bhalla further said that unaffordable vegetable prices bringing tears in eyes of common man. Most of them can't afford the vegetable and essential items at a high price at present. But common man does not have the choice to pick alternates because these are essential items and they can't live without these items. The commodity prices also rising from months and pulses price gone up in the last few days.

The edible oil prices also went up in last few months.

Bhalla asked the people that if they want to mitigate their sufferings, they must come under the banner of Congress Party whose leaders have sacrificed their whole life for the upliftment of poor masses of India.

Senior Congress leader accused the BJP Government of befooling the people of J&K by its false claims of development.

JAMMU: A delegation of newly elected office bearers of Tax Bar Association Jammu on Tuesday called on Union Finance Minister, Nirmala Sitharaman and Lieutenant Governor, UT J&K, Manoj Sinha at Raj Bhawan on Tuesday. The delegation consisted of Advocate Rakesh Kapahi President, Advocate Vikram Dubey Senior Vice President, Advocate Renu Verma Vice President, Advocate Dheeraj Bhasin General Secretary and Advocate Ishant Gupta Joint Secretary-cum-Treasurer. On the occasion, a number of issues and demands were highlighted by the visiting delegation, to which Finance Minister and LG both gave a patient hearing.

The delegation also handed over a memorandum to

Finance Minister highlighting numerous issues being faced by professionals as well as stakeholders under Goods and Services Act (GST) & Income Tax Act along with a charter of demands in larger interest of Tax Professionals.

Major demands and issues highlighted in the memorandum included launching of mechanism for revision of GST returns, simplification of GSTR 4 Annual filing related to composition dealer, matching of ITC shall be done on half yearly or yearly basis, establishment of GST Tribunals, extension of time limit for revocation of Su-Moto cancellation of registrations, granting new restoration under GST on fast track basis etc.

President, Tax Bar Association Jammu, Rakesh Kapahi also highlighted some

other issues faced under Income Tax Act especially regarding glitches faced after launch of new Income Tax Web Portal concerning about Digital Signatures, E-Proceedings, uploading and downloading of forms etc. "No doubt, new portal will take time to work smoothly but till the time, it becomes user-friendly, necessary measures may be taken so that assesses may not suffer for no fault of theirs and moreover, extension of dates will definitely attract more filing of returns and collection of revenue," he added.

Further, the delegation urged Finance Minister to kindly invite Tax Professionals and Advocates officially during GST Council meetings or on other platforms because they are working as a bridge between Public & Government and can represent public in a better way. The delegation also apprised LG about other problems being faced TAX Professionals / Advocates in J&K and requested him to direct JDA authorities for reserving some 'Parking slots' at Rail Head Complex, adjacent Excise & Taxation Building for advocates practicing in GST, Income Tax, Excise and other related matters.

JAMMU: A joint delegation of Confederation of All India Traders (CAIT), JKL and Chamber of Traders Federation Jammu, led by President CAIT, Neeraj Anand called on the Union Finance Minister, Nirmala Sitharaman and highlighted a number of issues being faced by the traders, seeking early resolution of the same. Welcoming Union Minister on her visit to the 'City of Temples' the delegation expressed gratitude towards the Minister for various landmark decisions of the Government like 'One Nation One Tax' which proved of immense benefit for traders. The delegation members also hailed efforts of Modi Government for taking various steps to provide a major boost to the industrial sector of Jammu & Kashmir.

After the meeting, the delegation

also submitted a memorandum to the Finance Minister and urged for early resolution of all highlighted demands and issues, in the larger interest of the trader fraternity.

Major issues highlighted in the memorandum included ensuring ease of doing business and liberal handholding by financial institutions, renewal of lease hold rights of Narwal Fruit

Mandi as administrative inertia is not allowing renewal of the leasehold rights to approximately 130 fruit merchants, dedicated budget to augment Transport sector and Yard conditions, clearing ambiguity in land laws regarding 'Gair Mumkin Khad' nomenclature, focused attention on tourism dependent trade stakeholders, revamping existing power infrastructure, waiving off interest on all sorts of trade loans, cash credit limits etc, atleast till March 2022, rescheduling of loans, re-capitalisation of small accounts, framing trade policy and start-up environment on lines of Industrial Policy, single window clearance, dedicated budget for promoting religious tourism, abolishment of bank charges or reducing the same especially while using debit/credit cards, simplifying GST rules, review of tax rate for footwear and Textile sector etc.

## Jitendra inaugurates separate Bench of CAT at Srinagar

SRINAGAR: Union Minister of State (Independent Charge) Science & Technology; Minister of State (Independent Charge) Earth Sciences; MoS PMO, Personnel, Public Grievances, Pensions, Atomic Energy and Space, Dr. Jitendra Singh on Tuesday inaugurated a separate Bench of Central Administrative Tribunal (CAT) at Srinagar to deal exclusively with service matters of government employees.

While the CAT Bench at Jammu started functioning with effect from 08.06.2020 and now with the issuance of notification (dated 17.11.2021) of jurisdiction of Srinagar Bench is also made functional. The Minister said with today's historic decision, now all three important agencies of DoPT- CAT, CIC and CVC are fully functional in UTs of J&K and Ladakh.

Dr Jitendra Singh said Jammu and Kashmir is the only State/UT in the country to have two CAT

measures to control the increasing unemployment rate in J&K despite tall claims made by administration regarding various initiatives being taken to control unemployment rate in J&K. The rising unemployment rate in J&K continues to be a lingering problem for youth who are forced to run after government jobs in absence of a strong private sector. Though the government claims that outside investments worth Rs 50,000 crore will come to UT, but till day no such development has been observed on ground.

It is quite understandable that youths and others, who were in private sector lost their jobs due to COVID-19, which also lowered GDP rate in the country. Automobile and textile sectors were first to cut their job policies due to economic downturn. As far as tourism sector is concerned, which was earlier backbone of J&K economy, it is already facing huge losses and hotel sector is also in a bad state due to unrest in Valley over

jurisdiction of Srinagar Prime Minister Narendra Modi accords special priority to J&K and he takes a keen interest in the matters and issues related to the new Union Territory. He said, two Benches for J&K will go a long way in not only reducing the burden of various Courts, but would also provide to the persons covered by the Adminstrative Tribunals speedy relief in respect of their grievances and service matters.

Dr Jitendra Singh informed that the Jurisdiction of Jammu Bench of CAT extends up to 10 districts of UT of J&K and one district (Kargil) from UT of Ladakh.

A Judicial Member, Shri D.S. Mahra as also the support officers and staff have been deputed at Srinagar Bench to manage its functioning. Dr Jitendra Singh concluded that Modi Government is committed to Transparency and "Justice for All" and the people friendly reforms taken in the last seven years have benefitted the entire country including people of Jammu and Kashmir and Ladakh. He said that more than 800 Central laws, which were not applicable to J&K have been made applicable

since the abolition of Article 370 and 35A on 5th August 2019 for the benefit of people of Jammu & Kashmir and now they enjoy same rights as people from the rest of India.

Dr Jitendra Singh said, with the notification of Tribunals Reforms Act, 2021 on 13.8.2021, the process for filling up of vacancies of Members in CAT has been started. Presently, the post of Chairman, CAT is occupied by Ms. Manjula Das and it has been the constant endeavour of the Government to strengthen the infrastructure in all the Benches of CAT for their smooth functioning. Referring to high disposal rate of cases, the Minister informed that since its inception in 1985 and up to 30.6.2021, the Central Administrative Tribunal received 8,56,069 cases for adjudication (including those transferred from High Courts), out of which 7,86,647 cases have been disposed of, leaving a pending

## Shocking data: J&K's unemployment rate further dipped to 22.2 pc

SRINAGAR: According to the Centre for Monitoring Indian Economy (CMIE) figures, J&K has a 22.2 percent unemployment rate, which is even higher than the national level unemployment rate of 7.1 percent, recorded across India.

The higher unemployment rate in J&K is a cause of concern as there seems to be no improvement in job scenario across Union Territory. In comparison to September, the unemployment rate has increased further. In September, CMIE has pegged unemployment rate in J&K at 21.6 percent which further lowered to 22.2 percent.

The unemployment rates are generated by CMIE using its Consumer Pyramids Household Survey machinery. As CMIE has pegged India's unemployment rate at 7.1 percent, it means Union Territory of J&K has much higher unemployment rate than national average. It clearly indicates that present administration is not taking effective
