## Why Popular Govts in J&amp;K State did not use Art-35A even for good of Permanent Residents of J&amp;K?

No doubt Art 370 of Constitution of India (COI) had remained in debates right since 1950. But it has been Art-35A that had been more in focus particularly after 2010 since its legitimate existence in Constitution of India had been put under question mark.

Art-35A bestowed on the J&K legislature / J&K Government in a way 'absolute constituent powers' for conferring exclusive rights on some Indian citizens categorised by State as 'Permanent Resident of J&K', within the state of J&K, to the extent of reserving 100% Government jobs/seats in government professional colleges/lands in J&K/J&K government aids only for all or some from amongst them. Whereas no other article of constitution of India has such absolute limits to keep a 'sector' totally reserved for one class of citizens

only. It was in 2018 that a young journalist from Kashmir valley visited me and said " Sir you are yourself an Indian citizen of the category of Permanent Resident of J&K and 'Art 35A' of Constitution of India gives authority to the State of J&K for ordering/ creating special constitutional privileges for Permanent Residents of J&K even then why are you (from Jammu region) against Art 35A when people in Kashmir valley are for retention/ preserving Art 35A ?" I could sense the style of his understanding on the subject keeping in view the statements (particularly after 2015) that were made by some senior Kashmir valley leaders even from the "ruling corridors" (that in a way appeared even suggesting to Supreme Court of India to be 'cautious' while hearing of the petition questioning the very existence of Art 35A).

To summarise I told him that I am not so simply against 'Art 35A' of Constitution of India for its contents and me being concerned for Jammu province only, what I think was for all

regions & religions of J&K since it was the way the Art 35A had been used by those in State legislature / J&K governments all these years (Art-35A had been used less to give favoring treatments / rights to the Permanent Residents of J&K and more to project to the outside World that J&K state is not 'purely' an Indian state like other Indian states). To be specific and brief I told him that had the 'Leadership' of J&K which so often talks of Kashmiri aspirations and the special rights secured for 'their people' after 1947 accession in terms of so called 'special status' Art-370 and Art-35A been truthful to their word they would have also done the real good / worked for doing some real good with the available "special" provisions for atleast the Indian citizens categorised as Permanent Residents of J&K ( let alone be even from even Kashmir valley) which they did not do rather even the existing bards of pre 1947 times were also repeatedly although the same were pointed out to those in 'power' like i. undoing the laws that violated the human rights/ fundamental rights of even the "women permanent residents of J&K" regarding 'choosing a life partner' ii. there being no reservation for even Schedule Tribe Permanent Residents of J&K in the Legislative Assembly of J&K even when Section-23 of JK Constitution talked of Schedule tribe iii that at time the seats in J&K assembly reserved for permanent resident Schedule Caste were 7 on the basis of total 76 active seats where as the number could be more in view of 87 total active seats iv. 5300 Families of 1947 POJK DPs who were State Subjects of princely state of J&K and were residing in other Indian states had been disowned by State wrongly taking shelter under 1971 Act of J&K Legislature concerning POJK DPs v. inadequate pro

Had the leadership done introspection sincerely , made the corrections and used the so called available "specials" to even

create provisions in education / health / local self government / socio- economic assistances / alround promotion of tourism/ local crafts / socio-economic support to senior citizens / destitute/backward better (which it could do) there would not have been more questions on Art-370/ Art-35A (accept the technicalities about the birth of Art 35A).

But since good sense was not prevailing on the leadership of the day and the so called 'special provisions' were more

also even benefit the separatist elements within ( and their supporters outside) the need was felt by even the meaningful permanent residents of J&K ( like me) to strip ourselves off of Art-35 / even Art-370 in original form so that atleast the separatist elements are devoid of some separatist threads in the interest of efforts being made for peace and stability in J&K.

The 'young friend' from Kashmir did appear making a positive nod to the opinion that there appeared no any chances of the conventional Kashmir valley centric prime leadership of J&K that had held the reigns of governance for more than 6 decades changing it's attitude and in future making use of the nearly absolute constitutional protections/ "reservations" available to the benefits of even the "permanent residents of J&K", so better let even Art-35A go.

So in the national interest in the run for finding out some way out from the constitutional cover provided by Art35Ato the wrongs done even to the Permanent Residents of J&K by State Government / elected representatives need was felt to rather see how the misrepresentation of Art-35A could be checked so that atleast the basic rights/ human rights/ fundamental rights of all the Indian citizens living in J&K are legally protected/ preserved and also the designs/ intentions of those who have been using Art35A more and more for directly or indirectly promoting the separatist ideologies are defeated / checked from adding more and more to the "ideological" pollution from which some innocent Kashmir Valley masses have been additionally suffering due to the anti India / anti 1947 Accession game plans of separatists/ Pakistan sponsored missions.

## Cleanest cities of India honoured at Swachh Amrit Mahotsav

The President of India Ram Nath Kovind felicitated the awardees of the cleanest cities of India at 'Swachh Amrit Mahotsav' hosted as part of Swachh Bharat Mission-Urban 2.0 by Ministry of Housing & Urban Affairs (MoHUA) at Vigyan Bhawan, New Delhi. The award ceremony, organized to recognize the good work done for Swachhata by towns/ cities, States and Union Territories under various initiatives of the Swachh Bharat Mission (Urban), viz. Swachh Survekshan 2021, Safaimitra Suraksha Challenge, and certifications for Garbage Free Star rating for cities - saw more than 300 awards under various categories being given away through the day.

For the fifth consecutive year, Indore was awarded the title of India's Cleanest City under Swachh Survekshan, while Surat and Vijayawada bagged the second and third spots respectively in the 'more than 1 lakh population' category. In the population category of 'less than 1 lakh', Vita, Lonavala and Saswad, all from Maharashtra, bagged the first, second and third positions respectively. Varanasi emerged as the 'Best Ganga Town' while Ahmadabad Cantonment won the title of 'India's Cleanest Cantonment', followed by Meerut Cantonment and Delhi Cantonment. In the category of 'Fastest Mover', Hoshangabad (Madhya Pradesh) emerged as the 'Fastest Mover City' (in the 'more than 1 lakh population' category) with a jump of 274 ranks from 361st position in the 2020 rankings to the 87th position this year, thus securing a place among the top 100 cities.

In the State awards, Chhattisgarh, for the third consecutive year emerged as the 'Cleanest State' in the category of "more than 100 Urban Local Bodies" while Jharkhand, for the second time, won the Cleanest State award in the "less than 100 ULBs category".

Karnataka and Mizoram became the 'Fastest Mover States' in the big (more than 100 ULBs) and small (less than 100 ULBs) state category respectively.

Speaking at the event, the President said that this year's Swachh Survekshan Awards have special significance because we are celebrating 'Azadi Ka Amrit Mahotsav'.

He noted that Safai Mitras and sanitation workers have continuously rendered their services even during the COVID pandemic.

He said that the government is committed to ensure that life of no sanitation worker is put at risk due to unsafe cleaning practices.

The President said that effective management of solid waste is essential to keep the cities clean.

He stressed that environment conservation has been an integral part of the traditional lifestyle of India. Today whole world is emphasizing on environment protection in which focus is on to reduce, reuse and recycle the resources.

He noted that good examples are coming out of the idea of 'Waste to Wealth' and many start-ups are active in these areas. He said that appropriate schemes could be developed to encourage entrepreneurship and investment in these areas.

Hardeep Singh Puri, Union Minister of Housing & Urban Affairs, speaking on the occasion, said that the achievements under SBM-U have been the result of unprecedented collective efforts.

He said that today, the Mission has taken the shape of a people's movement - a true 'Jan Andolan'. This is also reflected in the massive growth of the Swachh Survekshan which began as a pilot in 2016 among 73 cities, and is the world's largest urban cleanliness survey today. He said that the next few years will be dedicated to focusing on holistic cleanliness, i.e. Clean Air, Clean Land, and

Clean Water.

The Minister said that we owe it to our future generations to create greener and inclusive cities.

He congratulated the Swachhata Champions of urban India through this celebration, which is appropriately titled Swachh Amrit Mahotsav.

Hardeep Singh Puri and Kaushal Kishore, Minister of State for Housing & Urban Affairs also felicitated the awardee cities and States, in the presence of dignitaries including the Chief Ministers of Chhattisgarh and Sikkim, and Lieutenant Governor of Andaman & Nicobar Islands.

Over the years, Swachh Survekshan (SS) has emerged as an effective tool for transforming the urban landscape.

Despite the on-ground challenges posed by COVID-19, a team of over 2,000 assessors visited over 65,000 wards in a record time of 28 days. Maharashtra has successfully bagged a total of 92 awards, the highest by any State in this year's Survekshan, followed by Chhattisgarh with 67 awards.

Additionally, under the Prerak Daaur Samman, a new performance category introduced under Swachh Survekshan 2021, five cities - Indore, Surat, Navi Mumbai, New Delhi Municipal Council and Tirupati were categorized as 'Divya' (Platinum).

This year's Survekshan, participated by 4,320 cities, also saw an unprecedented number of citizens' feedback - over 5 crores, compared to 1.87 crores last year. SS 2021 has also helped identify over 6,000 innovations and best practices in sanitation and waste management from across the urban India. The second session of today's event was dedicated to Safaimitras, the frontline soldiers of Swachh Bharat Mission - Urban.

Commemorating World Toilet Day (19 November), this session saw the top performers under the first ever Safaimitra Suraksha Challenge being recognized.

ognized. Indore, Navi Mumbai, Nellore and Dewas emerged as the top performers across different population categories among 246 participating cities in the Safaimitra Suraksha Challenge, launched last year by MoHUA to eradicate human fatalities from hazardous cleaning of sewers and septic tanks.

Among the States, Chhattisgarh and Chandigarh bagged the award for best performing State and Union Territory under the Challenge.

In the last one year, the Safaimitra Suraksha Challenge has been able to propel the 'manhole to machine hole' revolution in urban India through initiatives such as credit linkages of Safaimitras with banks through the National Safai Karamchari Financial Development Corporation (NSKDFC), on-the-job trainings through the Sector Skill Council for Green Jobs and setting up of helpline number 14420 in over 190 cities - a citizens' grievance platform.

The vision of a Garbage Free India under SBM-U 2.0 was given further impetus by announcing the results of 3-star and 5-star rated cities under the Star Rating Protocol of Garbage Free Cities. A total of 9 cities - Indore, Surat, New Delhi Municipal Council, Navi Mumbai, Ambikapur, Mysuru, Noida, Vijayawada and Patan have been certified as 5 star cities while 143 cities have been certified as 3 star.

The Star Rating Protocol of Garbage Free Cities was introduced as a SMART framework by MoHUA in 2018, to holistically evaluate cities across solid waste management parameters. In 2018, only 56 cities were awarded certification on some star rating.

This year, the number has gone up manifold with 2,238 cities applying for the assessment. The mammoth exercise was completed successfully despite the COVID-19 restrictions as is evidenced in the numbers - 1.4 crore photographic evidence collected across 3.5
