provided credit," the finance minister said.

She said the schemes for the poorer sections that benefited the people across the country from a collective infusion of credit through farmer producer organisations or self-help groups are now seeing the light of the day in J&K.

As a result of this, the people feel they may be small but they can also access some kind of help from the government and credit from the banks, the minister added.

Seeking the cooperation of the people in facilitating outsiders to set up their units in Jammu and Kashmir, she said a lot of people want to come and set up industry here and take benefit from the industrial package of the government.

"I will invite more youth to come forward to set up their businesses in J&K. Of course, with more activities on the ground, we may attract people from everywhere else to partner with you (youth of J&K)," she said.

Sitharaman added, "I would certainly underline this fact that when people partner with you, they are not going to displace you or remove you but are strengthening you."

"You have your strengths but you need more help from resources coming from banks and elsewhere. Today banks alone cannot bring in that kind of equity for activities here," she said, growing activities on the ground would draw people that ultimately boost the economy of J&K.

Referring to the various initiatives of the J&K administration, she said, "I think it is important for two-way participation good schemes and good delivery from the government and good participation from the people and both are all equally required."

She said she will ensure more banking activities take place in J&K and credit help to the people in setting their businesses.

"Regarding budgetary support. I had a lot of discussion with the lieutenant governor and I shall like the chief secretary to meet officials in the finance ministry to work out any proposal for the next budget which we will definitely do," she said.

She also talked about the reforms in the taxation regime and said a new post of principal commissioner for income tax is being created as "we are able to serve the people of J&K better".

Under PNB's special scheme 'Shikara', credit up to Rs. 15 lakh will be provided for purchase/repair of Shikaras and houseboats. While, Shikhar scheme focuses on meeting credit requirements up to Rs. 2 crore for the Hotel, Tour & Tourism industry.

I always believe that capital gaps must be bridged for transition in small scale and cottage industries. The credit constraints cannot be a new normal when our capacity to invent new ideas is competing for recognition, observed the Lt Governor.

The Lt Governor underlined the need to forge a strong partnership between banks and business entities for greater investment, growth, innovation, and employment. I want the banks in J&K Union Territory to build floors of opportunities, not the walls, the Lt Governor added.

Galwan hero Col...

soldiers, Naib Subedar Nuduram Soren, Havildar (Gunner) K Palani, Naik Deepak Singh and Sepoy Gurtej Singh, who also laid down their lives valiantly fighting the Chinese troops in the Galwan Valley clash on June 15 last year, have been honoured with the Vir Chakra award posthumously.

Havildar Tejinder Singh of the 3 Medium Regiment, who was part of the Indian Army team at Galwan Valley clash and survived the combat, has also been conferred with the Vir Chakra award.

Vir Chakra is the country's third highest wartime gallantry award.

Naib Soren's wife Laxmi Mani Soren, Havildar Palani's wife Vanathi Devi and Naik Singh's wife, Rekha Singh, received the award from the President.

Sepoy Gurtej Singh's mother Prakash Kaur and father Virsa Singh received the Vir Chakra from the President.

Twenty Indian Army personnel had laid down their lives in the fierce hand-to-hand combat in eastern Ladakh's Galwan Valley clash, an incident that marked the most serious military conflict between the two sides in decades.

In February, China officially acknowledged that five Chinese military officers and soldiers were killed in the clashes with the Indian Army though it is widely believed that the death toll was higher.

The Rashtrapati Bhavan, in a tweet, said Col Babu displayed exemplary leadership, astute professionalism and conspicuous bravery in the face of the enemy and made the supreme sacrifice for the nation.

Colonel Babu, despite being grievously injured, led the Indian troops from the front with absolute command and control despite hostile conditions.

He valiantly resisted the enemy attack till his last breath, while inspiring and motivating his troops to hold ground, during the 'Operation Snow Leopard'.

The citation said Col Babu has been awarded the Mahavir Chakra for displaying "exemplary leadership, astute professionalism and supreme sacrifice" in the line of duty.

The Indian Army has built a memorial for the 'Gallants of Galwan' at Post 120 in eastern Ladakh.

The memorial mentioned their heroics under 'Operation Snow Leopard' and the way they evicted the Chinese People's Liberation Army (PLA) troops from the area while inflicting "heavy casualties" on them.

Naib Subedar Soren, who was part of the 16 Bihar Regiment, led his column and resisted the enemy's attempt to push back the Indian soldiers while establishing an observation post, according to official details.

He organised his column, countered the adversary forcefully and stopped them in their attempt to push back Indian troops.

Soren displayed raw courage, fighting with a resolute spirit before succumbing to his injuries.

Havildar Palani stood bravely and tried to defend his comrades even when the enemy attacked him with a sharp weapon.

His act of valour inspired other fellow soldiers to fight fiercely and resist enemy aggression. In spite of his grievous injuries, he continued to hold his ground resolutely and laid down his life for the motherland, according to the details.

Naik Deepak Singh, who too belonged to the 16 Bihar regiment and was performing duties as a nursing assistant, played a pivotal role in rendering treatment and saving the lives of more than 30 Indian soldiers.

Sepoy Gurtej Singh, who was from the third battalion of the Punjab regiment, successfully spotted the enemy troops while establishing the observation post.

Singh displayed raw courage and exceptional combat skills in resisting the enemy troops and kept fighting even after he was seriously injured, according to the official accounts of the clash.

Several other armed forces personnel were also honoured at the ceremony held at the Rashtrapati Bhavan.

Notable among them was the Shaurya Chakra awarded posthumously to Major Anuj Sood of the 21st Battalion, Rashtriya Rifles.

pandemic was 4,464 after two fresh deaths were reported in the past 24 hours. Meanwhile, the officials said there were 49 confirmed cases of mucormycosis

(black fungus) in the UT as no fresh case was reported since Monday evening.

COVID-19 cases...

rate was recorded at 98.32 per cent, the highest since March 2020, the ministry said.

A decrease of 4,859 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

The daily positivity rate was recorded at 0.79 per cent. It has been less than two per cent for last 50 days. The weekly positivity rate was also recorded at 0.93 per cent. It has been below two per cent for the last 60 days, according to the ministry.

The number of people who have recuperated from the disease surged to 3,39,46,749, while the case fatality rate was recorded at 1.35 per cent.

The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has exceeded 117.63 crore.

India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19.

India crossed the grim milestone of two crore on May 4 and three crore on June 23.

The 236 new fatalities include 180 from Kerala and 14 from West Bengal.

A total of 4,66,147 deaths have been reported so far in the country including 1,40,747 from Maharashtra, 38,177 from Karnataka, 37,675 from Kerala, 36,388 from Tamil Nadu, 25,095 from Delhi, 22,909 from Uttar Pradesh and 19,397 from West Bengal.

The ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

It will be executed by international bidder Zurich Airport International AG as concessionaire.

The groundwork for the first phase regarding land acquisition and rehabilitation of the affected families has been completed, the statement said.

This airport will be the second international airport to come up in Delhi-NCR, it noted and added that it will help decongest the Indira Gandhi International Airport.

It is strategically located and will serve the people of cities including Delhi, Noida, Ghaziabad, Aligarh, Agra, Faridabad and neighbouring areas, it said.

The airport will be the logistics gateway of northern India and due to its scale and capacity, it will be a game changer for Uttar Pradesh, the PMO said.

It will unleash the potential of Uttar Pradesh to the world, and help establish the state on the global logistics map, it said.

For the first time, an airport in India has been conceptualised with an integrated multi-modal cargo hub, with a focus on reducing the total cost and time for logistics, the statement said.

The dedicated cargo terminal will have a capacity of 20 lakh metric tonnes, which will be expanded to 80 lakh metric tonnes, it added.

By facilitating seamless movement of industrial products, the airport will play a crucial role in helping the region attract huge investments, boost rapid industrial growth and enable reach of local products to national and international markets, the PMO stated.

This will bring new opportunities for numerous enterprises and also create tremendous employment opportunities, it said.

The airport will develop a Ground Transportation Centre that will feature a multi-modal transit hub, housing metro and high-speed rail stations, taxi, bus services and private parking, according to the PMO.

This will enable seamless connectivity of the airport with road, rail and metro, the statement said.

Noida and Delhi will be connected to the airport through hassle-free metro service, as well as major nearby roads and highways like the Yamuna Expressway, Western Peripheral Expressway, Eastern Peripheral Expressway, Delhi-Mumbai Expressway and others will be connected to the airport.

The airport will also be linked to the planned Delhi-Varanasi High-Speed Rail, enabling people to complete the journey between Delhi and the airport in only 21 minutes.

The airport will also house a state-of-the-art MRO (Maintenance, Repair and Overhauling) service, the statement said.

The design of the airport is focused on low operating costs and seamless and fast transfer processes for passengers, it said.

The airport is introducing a swing aircraft stand concept, providing flexibility for airlines to operate an aircraft for both domestic and international flights from the same contact stand, without having to re-position the aircraft, the statement said, adding that this will ensure quick and efficient aircraft turn-arounds at the airport while ensuring a smooth and seamless passenger transfer process.

It will be India's first net-zero emissions airport, the PMO said.

It has earmarked dedicated land to be developed as a forest park using trees from the project site and the NIA will preserve all native species and be nature positive throughout the development of the airport.

Mercury drops further...

0.6 degrees Celsius. The mercury settled at a low of minus 3 degrees Celsius in north Kashmir's Kupwara.

Qazigund, the gateway to the Valley, recorded a minimum temperature of minus 2.2 degrees Celsius, while Kokernag registered a low of minus 1.1 degrees Celsius. The meteorological department has said that the weather is most likely to remain dry but cold till the end of this month.

However, there is a possibility -- 40 to 50 per cent chance -- of light snowfall over extreme north Kashmir parts on November 25, it said.

The wintry conditions in Kashmir have set in much ahead of the beginning of the extremely harsh weather conditions that usually start around the third week of December. 'Chillai Kalan', the 40-day period of harsh winter in Kashmir, begins on December 21 every year.

Poonch Admn set to intensify registration of unorganised Workers on e-Shram portal

POONCH: District Administration Poonch has decided to intensify registration of unorganised workers, including those working with the government departments to enable them to avail social security schemes being provided by the Government.

In this regard, Additional District Development Commissioner, Abdul Sattar on Tuesday chaired a joint meeting of government officials and civil society members to start the process on a major scale.

The meeting was attended by the officers of line departments, representatives of Beopar Mandal, social activists, media persons, representatives of self help groups etc.

Assistant labour Commissioner informed the meeting that the persons eligible for registration include construction workers, MGNREGS workers, Agricultural Workers, Horticulture workers, Gig workers connected with PHE, PWD, Irrigation and flood Control department, workers working in different shops and establishments, workers in transport sector, Civic workers, Street Vendors, Self Help Groups operating under different departments, ASHA workers, Anganwadi Workers, migrant workers etc. He further informed the meeting that the initiative of the government was aimed at covering all unorganized Workers between 16-59 Years of Age who are not a member of PF, EPFO, NPS, ESIC and not a taxpayer.

Giving further details, he said the registrations under the scheme can be done either through self registration or through CSCs by visiting the e-SHRAM portal on https://register.eshram.gov.in. The documents required for the registration on e-shram portal are Aadhaar Card, Aadhar linked active mobile number and Bank Account details. The registration on the portal is free of cost and beneficiaries will receive accidental insurance coverage through PMSBY. The workers will be paid Rs 2 lakh for accidental death and permanent disability and Rs 1 lakh for partial disability. The portal will not only provide social security benefits but will also assist the government to help all the eligible unorganised workers in case of pandemic or calamities. It will also help to keep a track record of the migrant labour workforce and will pave a path for more job opportunities.

The Additional District Development Commissioner reviewed the progress achieved so far viz a viz registration of temporary workers by the Government departments on the e-Shram portal.

The ADC said that Covid-19 Pandemic necessitated the creation of the E-Shram Portal to extend the benefits of the social security schemes to unorganized workers.
