SAMBA: Three persons got injured after an uncontrolled Tralla hit several vehicles on National Highway at Samba.

As per details, a Tralla hit rear side of a Gas Tanker; 2 cars (J K 0 2 C A = 7 6 6 6) and a motorcycle as a result of which three persons got injured, who were shifted to hospital for treatment.

The injured were identified as Sukh Paul (driver of Tralla), son of Bodh Raj, resident of Hoshiyarpur (Pb); Gursahib Singh (Cleaner of Tralla), son of Jaswinder Singh, resident of Faridkot (Punjab) and Akash (Biker), son of Nand Lal, resident of Hoshiyarpur (Punjab). Police has registered a case and started investigation.
