

SABLO seeks land at Baltal, Pahalgam for construction of Dharmshala, Bhandara Halls

JAMMU: A delegation of Shri Amarnath Barfani Langars Organisation (SABLO), led by its President Vijay Thakur and General Secretary Rajan Gupta called on LG Manoj Sinha on Monday and submitted a memorandum demanding allotment of suitable land for construction of Dharmshala (Yatri Niwas) for night shelter and Bhandara Halls for serving food to pilgrims at Baltal and Pahalgam.

While interacting with LG during sidelines of a function held to lay foundation stone for construction of Yatri Niwas for Shri Amarnath Yatris at village Majeen, near Sidhra in Jammu, the members of SABLO urged the LG for fulfilling their demand at the earliest in the larger interest of pilgrims.

Referring to the proposed construction of a Yatri Niwas, which would be built over 25 kanals of land by Shri Amarnathji Shrine Board at Pantha Chowk Srinagar, for accommodating more than 3,000 pilgrims, SABLO has urged the LG providing approximately 12 Kanals of land each at

Baltal, District Srinagar and Pahalgam, District Anantnag for construction of Dharmshala (Yatri Niwas) for convenience of pilgrims along with Bhandara Halls.

Pertinent to mention here SABLO, registered under Societies Registration Act 1860 in 2005, is an Apex Body of various Bhandara Organizations, which are engaged in rendering eleemosynary services of free food, distribution of blankets, night shelter facilities to pilgrims on both the routes to the Holy Cave during Shri Amarnath Yatra every year and acts as a bridge between SASB and Bhandara Organisations as well as pilgrims. After completion of the investigation the case was processed for obtaining Govt. sanction from competent authority and after obtaining the sanction, the case was challaned in court for judicial determination," said official adding that next date of hearing has been fixed on December 31, 2021.

Court rejects bail of snatchers

JAMMU: CJM Jammu Amarjeet Singh Langeh rejected bail applications of snatchers namely Balwinder Kour, wife of Kulwant Singh and Pavanjeet Singh, son of Narinder Singh.

According to case, a written report was submitted at Police post Gaggarh by complainant alleging therein that while she was coming home after attending a function at Jammu in vehicle bearing registration no. JK02CQ-7859 on November 14, 2021, she stopped for purchasing bakery from Jagdev Bakery Shop Gaggarh. A Scooty without registration number driven by an unknown Sikh boy and a woman pillion rider approached from opposite side and stopped Scooty near her. Complainant further alleged that pillion rider woman snatched her purse containing a Mangalsutra, 2 golden rings and cash amounting to Rs 20,000, ATM cards and some other documents. Based on this complaint, FIR no. 263/2021 for offence under section 382 of IPC

Tenant bound to pay fair & reasonable rent to landlord: Rent Controller

JAMMU: In an application for fixation of fair rent under J&K Houses and Shops Rent Control Act in case titled 'Dara Singh Vs Manoj Kumar', the Court of Rent Controller (Sub-Judge/CJM), Jammu while disposing of an application held that 'protection against un-fair eviction provided under rent control statute enjoins a corresponding obligation on tenant to pay reasonably fair rent to landlord' adding 'for non-applicant to hold out the possession of shop in question on monthly rent as asserted by applicant since 25.04.1996, does not square-up even with a modicum idea of fair rent for a shop situated at a place like Nanak Nagar- Jammu.' Accordingly, court fixed monthly rent of Rs. 6,000 (Rs six thousand only) as fair rent payable by tenant to landlord from the date of application.

Landlord/applicant moved application for fixation of fair rent before the Rent Controller (Sub-Judge/CJM), Jammu on November 5, 2020 submitting therein that he has rented out a shop measuring 10'x12' ft to non-applicant/tenant on rent @ Rs. 500/- per month on April 25, 1996 by virtue of registered Rent Deced and that as per condition in agreement, tenant did not execute fresh rent deed nor paid the rent

as per market rate. Further, according to applicant/landlord, an enhancement of Rs 400 only was made during 24 years of tenancy. While allowing the application, Rent Controller (Sub-Judge/CJM), Jammu fixed fair rent of Rs. 6,000 (Rs six thousand only) per month of shop in question to be paid by tenant to landlord from November 5, 2020, the day when application was presented before the Rent Controller (Sub-Judge/CJM), Jammu. JAMMU: Senior BJP leader and former deputy chief minister Kavinder Gupta on Monday said that NC leader Omar Abdullah is depicting youths of Kashmir in bad light just to satiate his own political motives as his party has lost relevance after BJP government put an end to Article 370 and has started winning hearts of people by realizing colossal development in every nook and corner of the Union Territory.

In a statement issued to media persons here, the BJP stalwart said that both Omar and NC Patron Farooq Abdullah have a habit to start taking the side of enemy nation Pakistan as they don't possess anything to showcase as far as their achievements during their tenures in government.

Diagnostic dilemma turned out massive heart attack at Ankur Maitrika Hospital

Patient treated, discharged from hospital within 24 hours

JAMMU: A very rare procedure was performed at Ankur Maitrika Hospital, here on an 30-year-old fit and young patient, who had a diagnostic dilemma.

To everyone's surprise, he said, there was complete blockage of one of the most important coronary arteries. It was successfully opened up using a medicated stent, Dr Neeraj said adding that the whole procedure was done via wrist (Radial artery approach), which is quite comfortable for the patient as the patient can walk immediately after the procedure.

Dr Neeraj said that to perform angioplasty from the radial artery is quite cumbersome for the doctor and needs a lot of experience. The patient was discharged from the hospital the next day. "In many cases of acute heart attack, an initial ECG

may be entirely normal or may show very subtle changes which are really hard to pick at times, so it is always advisable to repeat the ECG and take an expert's opinion whenever such a diagnostic dilemma arises," Dr Mahajan.

"An ECG was done in the ER that showed very subtle changes which were picked up by me," Dr Neeraj said, adding that the patient was immediately taken to Cardiac Cath lab for an urgent coronary angiography.
