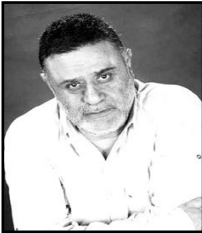

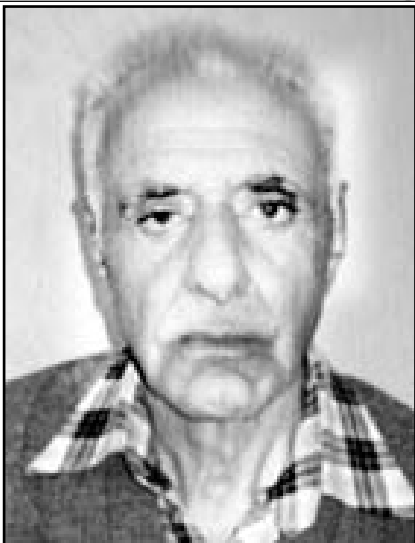
SHRADHANJALI
