tive and quick actions to minimize Covid-19 impacts, the Lt Governor termed rapid asymptomatic testing and contact tracing as important tools to help reduce the spread of the virus.

Test, Trace, and Isolate mechanism remains critical to the district's plan for tackling the pandemic, the Lt Governor said.

The Lt Governor directed the DCs, SPs and Health department to strictly enforce Covid Appropriate Behaviour in

Hospitals, Shopping complexes and other public places. He passed specific directions to the Health Department for monitoring all the relevant data on a regular basis for swift action.

Instructions were also issued to the concerned officials to ensure that restrictions on the public gatherings continue, besides declaration of Red zones and micro containment zones in areas registering surge in positive cases on priority.

While appreciating the efforts of the District Administrations for making tremendous efforts in the fight against Covid on various fronts, the Lt Governor observed that the good practices must be replicated by other districts as well for a better outcome.

During the meetings, the Lt Governor sought District-wise feedback on various critical aspects of covid management, and implementation of the directions passed in the previous meetings.

Kashmir on Saturday recorded 151 new positive cases of COVID, 16 from Jammu division and 135 from Kashmir division, thus taking the total number of positive cases in Jammu and

Kashmir to 332911. 69Moreover, more COVID-19 patients have recovered and been discharged from various hospitals including 16from Jammu Division and 53 from Kashmir Division.

According to daily Media Bulletin, out of 332911 positive cases, 1091 are Active Positive (123 in Jammu Division and 969 in Kashmir Division), 327380 have recovered and 4440 have died; 2177 in Jammu division and 2263in Kashmir division.

The Bulletin further said that out of 16431710 test results available, 332911 samples have tested positive and 16098799 samples have been tested as negative till date. Besides, 41,649COVID tests have been

JAMMU: The main road Rajouri to connecting Thanamandi was briefly closed for traffic on Saturday as security forces extended the ongoing search for a group of terrorists to the Khabla forest following information about their suspected movement in the area, officials said.

The counter-insurgency operation in Surankote and Mendhar forest in Poonch district and Thanamandi in Rajouri district entered the 27th day on Saturday.

While the operation to track down the terrorists in the forest belt of Poonch-Rajouri was underway, the security forces received information about the suspected movement of terrorists in the vast forest area of Khabla along the Mughal Road in the early hours of Saturday, the officials said. # Naming in 2011 whole of Jammu Division as Dogra Sambhag disturbed some conservative 'Kashmiri' leaders

**J**&K Revenue Department had ordered for issue of Dogra certificate vide Order No. Rev.(LB) 69 of 2011 dated: March 25, 2011 to people belonging to Jammu Division of J&K. Dogra Sambhag is known for its warrior inheritance. The order had to face 'serious' objections as made by some 'subjects of J&K'. What was there in Dogra Certificate that disturbed some Kashmir Valley leaders? Dogra certificate Mein Aesa Keyaa Hai Jis Se Geelani Aur Mehboob Baig Jaesae Log J&K Kee Ekta Ke Livae Etnae Chintit Ho Geyae The? Etna Jaroor Tha Ki Dogra Certificate se Oon Logoan Ko Jaroor Dhakka Lga Thai Jo Jammu division Ko Hindu Aur Muslim Bahul Elakoan Mein Bantna Chahtae Hain.

To be brief the Dogra Sambahg/region is bound on the north by the Pir Panjal Range of the middle Himalayas, in the south by Punjab, on the east by Ladakh and is bordering Pakistan.

Jammu Division Dogras though traditionally more inhabited the Shivalik range of mountains but they are spread over whole of Jammu region. Majority are followers of Hinduism but a large number of Jammu

Dogras believe in Islam as well. The first Param Vir Chaktra of Swantra Bharat was also awarded to a Dogra from today's Himachal Pradesh PVC Major Som Nath Sharma. Demands have been regularly made over last one decade for honoring the descendants of family of atleast the first Param Vir Chaktra decorated soldier of Swantra Bharat Maj Som Nath Sharma, a Dogra, with Permanent Resident of J&K Status and for naming the Srinagar International Airport as PVC Maj Som Nath Sharma International Airport Srinagar, it is hoped that what the earlier J&K State Government could not do will surely be done the present J&K UT Government under President Rule.

Some people in Kashmir Valley including the separatists like late Ali Shah Geelani objected to issue of Dogra Certificate. No objections to the issue of Dogra Certificate came from any part of Jammu Division / Region. So strangely some so called main stream leaders and even a National Conference Member Parliament too stood with the 'objections'. Even the Middle East's English language daily Arab News said on 8 April that March 25th Dogra Certificate order of J&K Government may stir unrest in Kashmir. But the leaders from Jammu did not stand that firmly with Omar Abdullah Government

With pressures mounting the then Omar Abdullah for some relaxations in recruitment standards. It all did not end there . It was on April 22, 2011 that Union Ministry of Home Affairs issued an order under the signatures of Director (Personnel) Ajay K Singh ordering that the relaxation in chest and height, which was earlier applicable to Kashmir, Leh and Ladakh regions of J&K would now be applicable to residents of entire J&K State. And J&K Government referring the MOHA orders in principle withdrew the orders of March 25, 2011 on April 28, 2011.

The leaders from Kashmir valley so often talk of Kashmiriat and Kashmiri interests. They do not see

any dangers to integrity of J&K when they see J&K only in 'Kashmiriat'. But when the then revenue Minister in NC lead NC-Congress J&K Government Raman Bhalla talked of DOGRA identity as whole Jammu Division, the Kashmiri leaders saw dangers to J&K

How funny some Valley leaders were even quoted as having said that Dogra Certificate was intended to divide J&K on Communal / ethnic lines. Whereas Raman Bhalla had clarified that all the residents of Jammu Division (Jammu Province of erstwhile J&K State of Maharaja Hari Singh) whose elders were residents of J&K in 1944 are Dogras irrespective of the religion, ethnicity, even dialect but still the Kashmiri leaders echoed their objections.

It was not the job opportunities that disturbed some Kashmir Valley leaders. It was the definition of Dogra that had disturbed not only Sayeed Ali Shah Geelani but some Kashmir centric leaders even from so called main Stream parties who had succeeded in exploiting the innocent people of Kashmir valley in the name of Kashmiriat and Religion.
