

# Dulloo reviews ODOP scheme, status of LSD in J&K

JAMMU: Additional Chief Secretary (ACS), Agriculture Production Department, Atal Dulloo on Wednesday reviewed the progress under the Prime Ministers Formalization of Micro Food Enterprises (PMFME), One District One Product (ODOP) scheme.

The meeting was attended by senior officers of Agriculture Production Department in hybrid mode, besides the District Nodal Officers, District Resource Persons and Representatives of Financial Institutions of J&K Bank. Special Secretary Agriculture Production Department (State Nodal Officer), Mohammad Farooq Dar gave a detailed presentation during the meeting wherein it was informed that 437 applications were submitted of which loans in 102 cases amounting to Rs 964 lakh has been sanctioned by J&K Bank and other financial institutions in favour of the Food Processing Entrepreneurs.

He also gave the details of capacity building initiatives taken by SNA for the beneficiaries and also the details of the promotional activities to be

undertaken were also shared. Additional Chief Secretary directed that the District Nodal Officers/ DRPs shall ensure submission of at least 10 applications per month and sanction of at least 5 cases per district from the Financial Institutions in order to meet aggregate target of 552 set by the Ministry of Food Processing Industry Govt. of India (MoFPI).

Dulloo instructed that all District Nodal Officers and lead Bank Managers shall be held accountable for sanction of loans. It was also informed in the meeting that the District Nodal Officers are facing challenges with respect to sanction of loans from the JK Bank and other Financial Institutions.

He asked the bank representatives and DNOs of Reasi and Udhampur to submit the

details of cases to the State Nodal Agency, which have been rejected by the Banks for detailed analysis and taking corrective measures.

The ACS was also directed JKHMP and JKAGROS to ensure implementation/setting up of Common Incubation Center for Honey in Ramban and two Common Infrastructures, one each at Chadoora, Budgam and Samba for Jammu Division after proper and due diligence with respect to new guidelines issued by the Ministry in this regard.

JKHMP was instructed to expedite outsourcing of the completed CICs and furnish utilization certificate to the SNA for necessary reconciliation with the Ministry.

It was also informed that M/s Transgraph Hyderabad who has been engaged by

SKUST-K for State Level Upgradation Plan (SLUP) under the scheme shall submit recommendations regarding the upgradation plan on or before 15 December-2022 for necessary approval.

Later, the Additional Chief Secretary, also chaired a meeting to review the status of Lumpy Skin Disease (LSD) in Jammu and Kashmir.

The ACS took district wise review on the present status of the lumpy Skin disease besides elaborating on controlling measures being taken up like vaccination, use of medicines, procurement of vaccines, sample collection for testing through a presentation. ACS stressed upon the officers to complete a 100% target to vaccinate Lumpy Skin animals in every district to control the disease as early as possible.

During the meeting it was informed that till date 70614 animals have been affected with Lumpy Skin Disease in which 60615 animals have been recovered so far.

Among others, senior officers of Animal Husbandry and allied Departments attended the meeting in person and through VC.

# Implementation of NTEP in J&K reviewed

JAMMU: Secretary Health and Medical Education, Bhupinder Kumar, on Wednesday convened a meeting to review progress on implementation of National Tuberculosis Elimination Programme (NTEP) in Jammu and Kashmir at Civil Secretariat here.

Secretary, while addressing the meeting, highlighted the importance of National Tuberculosis Elimination Programme for eradication of Tuberculosis from the UT by or before year 2025. He exhorted upon the officers to accord high priority to "Pradhan Mantri TB Mukh Bharat" as their prime duty towards citizens' welfare making this campaign a mass movement.

He directed the Director Health Services, Jammu and Kashmir to further intensify their efforts in registration of NI-KSHAY Mitras on the portal Ni-kshay 2.0. He also emphasized upon the Program Officers to make consistent efforts in monitoring the TB case notification and treatment besides ensuring real time reporting and community participation as key indicator.

Action points for strategic state plan were also discussed in the meeting, wherein both STOs were asked to submit proper targets and timelines against different indicators.

Secretary also directed for increasing TB testing in both

the divisions of J&K so that maximum number of TB patients can be diagnosed and treated.

# DENGUE

## How to Identify, How to remain safe

### Symptoms of Dengue

Dengue Symptoms  
Fever with any of the following

- Abrupt onset of High Fever.
- Severe Frontal Headache .
- Pain behind the Eyes, which worsens with eye movement.
- Muscle, Bone and Joint pains.
- Nausea, Vomiting.
- Skin Rash.
- In severe forms of Dengue, Bleeding from nose, mouth & gums due to internal bleeding.

### How to Prevent

- Avoid water stagnation as mosquito responsible for Dengue breeds in stagnant water.
- Keep water containers tightly covered.
- Empty coolers and other small containers at least once a week.
- This mosquito is a Day biter, wear clothes that cover full body.
- Use mosquito repellent sprays, creams etc.
- Use mosquito nets (preferably medicated) while sleeping.
