2 Whereas, the General Administration Department vide Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 has made it mandatory for selected candidates to submit their Personal Verification Rolls

v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.

C) The appointment of the above candidate(s) is further subject to the following conditions:-
