



officers were able to recover 281.5 Kg Poppy Straw packed in 30 Apple Boxes. The driver of the said vehicle identified as Showkat Ahmad Naik, son of Nazir Ahmad Naik, resident of Okey Kulgam was arrested and vehicle used in commission of crime was also seized. However, two other persons namely Suhail Ahmad Bhat alias Sayar, son of Mohd Maqbool Bhat, resident of Okey Kulgam and Mohd Yaqoob Beigh alias Yuka Buda, son of Mohd Abdullah Beigh, resident of Jan Mohalla Shopian managed to flee from spot and efforts are on to arrest them. Accordingly, cases under relevant sections of law were registered at respective police stations and investigations started.

SRINAGAR: Continuing efforts to eradicate the menace of drugs, Police on Thursday arrested four drug peddlers in Budgam & Kulgam and recovered huge cache of contraband from their possession.

As per details, Police Station Khag received information that one Abdul Rashid Malik, son of Ghulam Mohammad Malik, resident of Shunglipora Khag has kept contraband substances in his house at village Shunglipora Khag. Acting swiftly, a police party of Police Station Khag along with Executive Magistrate 1st class raided specific location and recovered 4 Kg Cannabis Powder and 9 Kg cannabis leaves. He was arrested and shifted to police station. In another action, a police party of Police Post Narbal at a check-point established near Railway Bridge Kooosoo Khalisa intercepted 2 suspects who on seeing police party tried to flee, but were apprehended tactfully. They were identified as Bilal Hussain Poswal, son of Mohd Khan Poswal, resident of Arnas Reasi and Mohd Arif Kasana, son of Ab Aziz Kasana, resident of Parnod Ramban. During search, 4 Kg Poppy Straw was recovered from their possession. Similarly in Kulgam, acting on a specific information regarding transportation of contraband substances in the jurisdiction of Police Station Kulgam, a police party led by SHO Kulgam established a special checkpoint at Areha (Awhatto Crossing). During checking, a suspicious vehicle (Load Carrier) bearing Chassis number NYF 29975 with 3 persons on board was signaled to stop however, the driver tried to flee but was chased by the alert police party & intercepted tactfully.
