

Marh Kanachak Distt Jammu from Kotla Mubarakpur Delhi. Finally the girl was recovered from his custody.

Subsequently the girl was handed over to her family members after completing all the legal formalities.

**Hit & run case solved within hours; accused arrested****STATE TIMES NEWS**

BUDGAM: Police on Saturday solved a hit and run case within hours by arresting an accused person involved in the commission of crime and also seized the vehicle.

As per the details, Police Post Soibugh received an information at about 1030hrs, an accident was reported at Hakermulla Budgam, wherein an unknown vehicle hit and injured a pedestrian namely Iman Gulzar age about 15 years, daughter of Gulzar Ahmed Hajam resident of Harkarmulla Budgam. The injured was taken to JVC Hospital for treatment where she succumbed to her injuries.

Accordingly, a case vide FIR number 381/2022 under relevant

sections of law was registered in Police Station Budgam and investigation was initiated.

Acting swiftly, a police party led by I/C Police Post Soibugh SI Gowhar Ahmad started a hot pursuit of the unknown driver and they were successful in arresting the accused driver after hectic efforts within hours of the incident. He has been identified as Shahid Nazir son of Nazir Ahmad Hajam resident of Harkarmulla Budgam. He has been shifted to police station where he remains in custody. The vehicle bearing registration No. JK04G-9135 involved in the hit & run case has also been seized. Further investigation of the case is in progress.
