

ACS reviews status of flagship schemes tailored for farmers' welfare

JAMMU: Additional Chief Secretary (ACS), Agriculture Production Department (APD), Atal Dulloo, chaired a meeting to review the status of flagship schemes tailored for farmers' welfare at civil secretariat here on Monday.

The meeting was specifically called to review Kisan Credit Cards, Soil Health Card and Pradhan Mantri Kisan Maandhan Yojana (PMKMY).

ACS assessed the status of generation of Kisan Credit Cards and directed the officers that credit flow through the cards be increased. 'Credit flow as well as ticket size of the loans needs to be raised for increased benefits to the farmers', he stressed.

ACS asked for developing an integrated portal of KCC for all districts of the UT and was informed that work on the same has already been initiated.

Dulloo reviewed the status of issuance of Soil Health Cards and was informed that 100 percent saturation has been achieved in this regard. Since the cards are regularly

updated, the ACS was told that the process of their updation is going on as per schedule.

ACS said that farmers should be educated about the benefits of Soil Health Card and therefore, the Agriculture Department and its extension functionaries need to organise awareness campaigns.

He also reviewed the status of Pradhan Mantri Kisan Maandhan Yojana insurance disbursal and gave time bound targets for insurance disbursal in both divisions of the UT. He also directed the officers to increase coverage under the scheme.

Pertinently, PMKMY is a government scheme meant for old age protection and social security of small and marginal farmers.

Those present at the meeting included Secretary in APD, Shabnum Kamili; DG Planning APD; Director Agriculture Jammu, KK Sharma; Director Agriculture Kashmir, Chowdhary Mohammad Iqbal and MD Agro among other senior officers.

Post MBBS DNB & Post MBBS Diploma Courses:

- NEET PG Score Card- 2022 conducted by National Board of Examination (NBE).
- Domicile of UT of J&K/Ladakh as the case may be.
- NOC issued by Health & Medical Education Department of J&K Government for the year 2022.
- Valid Category Certificate, if any.
- Any other documents required by the College/ Institution concerned at the time of admission.

Post Diploma DNB Course:

- PDCET Score Card-2022 conducted by National Board of Examination (NBE).
- Post MBBS Diploma in either of the following streams/disciplines:
 - Anesthesiology (b) Psychiatry (c) Obstetrics & Gynecology (d) Pediatrics.
- Domicile of UT of J&K/Ladakh as the case may be.
- NOC issued by Health & Medical Education Department of J&K/Ladakh as the case may be for the year 2022
- Valid Category Certificate, if any.
- Any other documents required by the College/ Institution concerned at the time of admission.

It shall be sole responsibility of the Colleges / Institutions to ensure proper check and verification of documents/ eligibility as per guidelines NMC (MCI) before the candidates are allowed for admission and in case any discrepancy in the requisite documents is found the same shall be reported to the Board for further course of action under rules.In order to complete the admission process within the prescribed cut-off date, the Colleges / Institutions shall keep their admission counters open even on holidays/ off days and designate Nodal Officers to facilitate the candidates to complete their admission process well in time. However, the candidates should in their own interest avoid waiting for the last day to complete admission formalities since delay has the potential of causing hardships to the candidates.

Further, as provided under Section 9(2) of J&K Reservation Act 2004, the Reserved Category seats which remained unfilled due to non-availability of eligible Reserved Category Candidates during this round of counseling were converted into Open Merit and filled up accordingly as per merit / preferences of the candidates.
