

University of Jammu holds 118th Syndicate Meeting

Endorses Rs 30,000 publication grant; Rs 50,000 for organizing programmes

JAMMU: The 118th meeting of the Syndicate of University of Jammu was held on Monday under the chairmanship of Prof Umesh Rai, Vice-Chancellor, University of Jammu during which various academic and administrative matters were discussed. In his opening remarks, Prof Umesh Rai extended a warm welcome to Rohit Kansal, Principal Secretary to Government, Higher Education Department, Shadi Lal Pandita, Director General Codes, Finance Department; Abdul Majid Butt, Director (Finance) Higher Education Department and other members of Syndicate for their wholehearted support to University of Jammu. While deliberating on the broad contours of National Education Policy (NEP-20), Prof Umesh Rai underlined that basic idea of NEP is to dissolve boundaries between different disciplines and evolve education. Central Govt should restore statehood, address other major issues in J&K: Tara Chand

JAMMU: Stressing the need for restoration of statehood to Jammu and Kashmir; the former Deputy Chief Minister Tara Chand said that the central government should also address various issues confronting the people in this border region of the country.

"People in this part of the country are feeling dismayed ever since its status was reduced from a full-fledged state to a union territory and they have been expressing this feeling through many democratic ways", Tara Chand, who is also a senior leader of Democratic Azad party (DAP), said while addressing a public meeting at Bomal in Akhnoor Constituency last evening.

The leaders in the present central government need to ponder on this issue afresh and restore the status of J&K as a state, which will go a long way in bringing peace, tranquility and progress in this region, he said, adding "it would be in fitness of things if J&K's statehood is restored before holding of Assembly elections".

Tara Chand, a former Speaker of J&K legislative Assembly, also referred to sev-

eral other problems being faced by different sections of people in Jammu and Kashmir and sought the attention of both the UT and central government to address them on an urgent basis.

Unemployment and price rise is at its peak in J&K and people feel dejected with the administrative machinery for ignoring these aspects, he said and urged the authorities to take serious note of these issues for redressal.

Growing unemployment can result in acute resentment, which can have many portents and may result in violence of one or the other form, he said while urging the government to deal with this issue seriously.

"Everyone wants peace and

tranquility and development in Jammu and Kashmir and those who are at the helm of affairs must devise systems to ensure these objectives on a fast-track basis", the DAP leader said.

NEW DELHI: Finland Minister of Education and Culture, Petri Honkonen called on Union Minister of Science and Technology, Dr Jitendra Singh at North Block here on Monday to seek enhanced bilateral cooperation between the two countries in the field of Science, Technology and Innovation (STI).

He was accompanied by a high level delegation which later held a separate meeting with the Indian delegation in the presence of the two Ministers.

While, Dr Jitendra Singh reiterated India's focus on collaboration in StartUps, the

Finland Minister was full of praise for Prime Minister Narendra Modi for management of Covid pandemic and also the efforts of the Union Government of India in ensuring development of vaccines and vaccination for all the countrymen. India and Finland agreed to carry mutual cooperation between the two countries to a new level in a number of areas of bilateral as well as global interests. Two nations decided to enhance cooperation in areas such as Digital Partnership in Future ICT, Future Mobile Technologies and Digital Education. The two countries also emphasised on

having institutionalised joint working groups on areas of mutual interest.

This was reiterated by Union Minister Dr Jitendra Singh and the Finland Minister Petri Honkonen. Dr Jitendra said, the bilateral STI collaboration between the two countries is an attempt to stimulate innovative R&D projects that address a specific need or challenge; demonstrate high industrial relevance and commercial potential; and aim to deliver benefit to all participants, and more broadly, to both nations. Dr Jitendra Singh conveyed to the Finland Minister that India is keen to develop research collaborations with Finnish R&D institutions and technology collaboration with Finnish Industry especially focusing on the application of Quantum Computing. Honkonen assured Dr Jitendra Singh that Finland is keen to cooperate with India in 5G, Environment and Clean Technologies, Bio-based Economy, BioBanks and Affordable Healthcare.

Project Flower Valley: Patnitop Tourism Circuit embraces flower power

PATNITOP: The ever-enchanted Patnitop Tourism Circuit embraces the flower power with Patnitop Development Authority's 'Project Flower Valley', aimed at spurring tourism, biodiversity and socio-economic development.

"Flowers are big business. Millions of them are sold as cut or loose flowers, processed into oils, dyes, edibles, beverages, medicines, cosmetics, incense sticks, powders, and various other value-added products. When they bloom, their ephemeral beauty attracts admirers. Throughout their natural life cycle, and even beyond, they are source of beauty and business. Hence, we teamed up with experts from different domains and Panchayati Raj Institutions to herald the Project Flower Valley in our jurisdiction," said Thakur Sher Singh, CEO PDA.

"In the initial phase of the project, some ninety thousand seedlings of flowering plants, mostly lavender, have been planted since last year over an area of 12.50 acres," he added.

Seventy thousand lavenders procured from Doda District of Jammu and Kashmir UT, have been planted at multiple locations of the PDA jurisdiction in the months of September-October, 2022.

Meanwhile, other flowering plants including varieties of cosmos, marigold, etc, nearly 20,000 in number, have been planted as per their appropriate seasons in the years 2021

and 2022.

As some of these seedlings planted around the ancient Mani Mahesh Temple, situated enroute Nathatop, burst into flowers, visitors are stopping by to capture their stunning sight and scent. The temple has supported the initiative by giving its land. However, full bloom is expected to most likely occur in the months of March-April, 2023. Around the same time of the year, Sanasar Lake witnesses the annual Tulip Festival, celebrating the brief appearance of colourful Tulip bulbs.

Given the highly conducive climate and soil of this region, various kinds of flowers, especially perennial flowers, will be planted at different locations under the Project Flower Valley in the coming times.

"A little patience, and woods, meadows and mountain slopes will be dotted with blossoms and blooms. It will be a floral, rather a botanical spectacle, adding to the avenues of attraction for the tourists in the Patnitop Tourism Circuit. It will expand the itineraries, as well as the stay of the tourists," said CEO PDA.

He added, "Furthermore, it will provide plenty of opportunities for new, young and innovative entrepreneurs to start flower-based initiatives and provide gainful employment to the locals. From flower farming to flower selling to flower processing, locals can venture into the huge flower industry however they like."

Explaining the calculations, the

Officer says that seventy thousand flowering plants produce approximately 156 litres of oil per year, which is sold at a rate of Rs 1500 per litre. This brings a revenue generation amounting to Rs 23,40,000 in a year.

In addition, these plants produce approximately 4,50,000 seedlings in a year which when sold at a rate of Rs 5 per seedling, will bring a revenue generation of Rs 22,50,000 in a year.

That is, a yearly revenue generation of Rs 45,90,000 only from oil extraction and sale of seeds or seedlings of flowering plants. The project will come to fruition in atleast three years. In twelve years, the number will rise to Rs 5,50,80,000.

Applauding the Project Flower Valley, Parkash Chand, BDC Chairman Chenani, said, "This is the first-of-its-kind flower-based project introduced in Jammu Division, which will not only boost the tourism in the Patnitop Tourism Circuit, but will also spark entrepreneurship, provide rural employment, encourage returning to agriculture, increase revenues, boost biodiversity, and bring in holistic development. It will constantly evolve over the time, depending on the requirements and developments."

PDA is making continuous efforts to not only increase and promote, but also innovate the tourism offerings in its jurisdiction, and such a concept of self-sufficient flower business, though at the initial stage, is another feather in its cap.

From the revenue generated through visitors, sale of flowers, seeds/seedlings, and flower-based products, PDA and PRIs will put in place more and better tourist amenities, tourist activities, kiosks, cafeterias, view-points, and so on. The domestic flower economy will change the fortunes of the villages of this circuit.

"Patnitop Tourism Circuit has always been a tourist's favourite, but in real sense, it is now that is being explored, developed and promoted, and the socio-economic benefits of tourism are starting to reach the local rural population," BDC Chairman added.
