Man nabbed with poppy straw

NOWSHERA: Foiling a narcotics smuggling bid, Police arrested a person alongwith consignment of poppy straw like substance which he was smuggling from Lam area.

In an official statement, police said that a team Lam police post headed by police post incharge Razaq Ahmed was on routine naked checking at Thandikassi on Lam - Keri road and a vehicle tata mobile JK11F 6986 coming from Bhawani area was intercepted for checking.

During checking of the vehicle, two bovines were found loaded in the vehicle following which it was put to thorough frisking that resulted in recovery of 500 grams of poppy straw (bukki) like substance from the vehicle.

Taking action, driver of vehicle namely Sumit Kumar son of Tilak Raj resident of Bhawani ward 1 has been arrested and cognizance of the matter has been taken up.

SSP Rajouri Mohammad Aslam said that action against those involved in unlawful activities is a priority of police and necessary steps are being taken in this regard.
