

GDC Nowshera celebrates birth anniversary of Rani Lakshmbai

NOWSHERA: The Women Development Cell of GDC Nowshera paid tributes to Rani Lakshmbai on Saturday by celebrating her Birth Anniversary. Popularly known as "Jhansi Ki Rani", she was one amongst the first women freedom fighters who revolted against the Britishers in 1857. Dr. K.K. Sharma, Principal of the college was the Chief Guest on this occasion.

While addressing the students and the staff, Dr. K.K. Sharma highlighted the important role played by Rani Lakshmbai in freedom struggle of India. He focused on her bravery, perserverence and courage.

He said that Rani Lakshmbai is a symbol of Heroism and Woman Power. Ten students presented Speech on life-history and freedom struggle of Rani Lakshmbai, three students sang songs in her praise and two students performed dance. As many as 80 students and all the staff members attended the function which was held in Smart Classroom of the college. Prof. Joginder Singh, HOD Physics; Prof. Davinder Kumar, HOD Hindi; Prof. Rajat Bhardwaj, Asstt. Prof. Sociology and Dr. Akhil Khajuria, HOD Physical Education also expressed their views on this occasion.

The entire programme was organized by Prof. Pooja Devi, Convener Women Development Cell. While addressing the audience, she emphasized that we should learn a lesson from the life history of Rani Lakshmbai who despite all the odds in her life revolted against the British rule and set an example of Outstanding Bravery and Courage.
