Successful bidder has to provide Supervisory Vehicles along with driver, as mentioned herein-above, in excellent running condition to the Directorate of Samagra Shiksha J&K/Mission Director, PM POSHAN for its office in Jammu at Opposite Gurdwara, Channi Rama Bypass Jammu), and in Srinagar Bagat-e-Barzulla, Behind Bone & Joint Hospital, Srinagar.
2. Vehicles will remain at the exclusive disposal of the Directorate of Samagra Shiksha/ Mission Director, PM POSHAN both at Jammu/ Srinagar and cannot be used by the bidder for any other purpose during the period of Rate Contract.
