

# Div Com reviews arrangements for JKSSB Exam

JAMMU: Divisional Commissioner Jammu, Ramesh Kumar on Monday convened a meeting to review the preparations for forthcoming written examination to be conducted by J&K Services Selection Board (JKSSB) for various posts.

Chairman JKSSB, Rajesh Sharma; Additional Commissioner, Pankaj Katoch; SSP Jammu, Chandan Kohli; Joint Director Information, Sapna Kotwal; Secretary JKSSB, Sachin Jamwal; Deputy Director Planning, Munish Dutta and other concerned officers attended the meeting in person while Deputy Commissioners Samba & Kathua and SSPs of Kathua, Samba, Jammu and Udhampur participated in the meeting through video conferencing.

The meeting discussed measures to be taken at dif-

ferent levels to ensure fair and smooth conduct of the exams.

While giving details of the forthcoming exams, the Chairman JKSSB informed that the Board has initiated the process for conducting written examination for selection against different posts through Computer Based Test (CBT) from November 29, 2022, while the exam for Junior Engineer Civil (Jal Shakti Department) Exam would be conducted from December 5 to December 6, 2022 and the examinations for the post of Sub Inspector (Home Department) is scheduled to be held from December 7 to Dec 20.

Giving details of steps taken, the meeting was informed that the Board has resorted to Third Party Audit of Computer Centres and installation of jammers in the exam centres for free and fair conduct of the test(s).

Maintaining that the credibility of centers was the vital factor in ensuring conduct of fair and transparent examinations, the Div Com directed the concerned Deputy Commissioners and SSPs to thoroughly scrutinize the conduct and past history of the identified centre well before the start of examinations. He also asked the DCs and SSPs to inform JKSSB about the adverse report against the identified centres, if any. He stressed on putting in all possible measures for foolproof security, maintenance of law and order, provision of logistic support for successful conduct of examinations.

The SSPs were directed to deploy an adequate number of men and women police personnel for frisking and other arrangements at various centres.

The Div Com also directed DCs concerned to make available proper arrangements of uninterrupted power supply, water supply and other amenities in the examination centres during the examinations and ensure that the candidates are not put to any discomfort.

The Div Com stressed that no electronic gadgets be allowed in the examination halls. He asked the KSSB to issue instructions for the information of candidates and also ensure wide publicity of these instructions.

The Div Com directed DCs to nominate observers/magistrates besides computer expert observers for each centre after checking the credentials.

## Improper implementation of instructions forcing authorities to issue orders repeatedly

SRINAGAR: Over the years, the government has issued repeated orders directing the government school teachers to refrain themselves from taking private tuitions. However, the orders see poor implementation on ground level as teachers continue to take classes at private centers. Due to improper implementation of orders, the School Education Department (SED) is forced to issue orders every winter prior to the commencement of the new academic session in the schools. The SED invoked Rule 10 of J&K Government Employees

(Conduct) Rules, 1971 and issued circular instruction to teaching faculty to prohibit them from taking private tuitions. The government stated that no government employee, whether on leave or active service, shall except with the previous sanction of the government engage directly or indirectly in any trade or business or undertake any other employment. The government also referred to the Chapter (IV) section 28 of the RTE Act, 2009 which prohibits private tuition by teachers saying that "No teacher shall engage himself or herself in private tuition or private teaching activi-

ty." The Principal Secretary SED, Alok Kumar in his circular said that some members of teaching faculty of SED were undertaking coaching assignments in private institutions and coaching centres even during school hours in violation of Rule 10 of the J&K Government Employees (Conduct) Rules, 1971 as well as Chapter (IV) Section 28 of RTE Act, 2009.

Director School Education, Jammu and Kashmir division besides all Chief Education Officers, Zonal Education Officers, Principal of Higher Secondary Schools and

Headmasters of all government schools have been entrusted with the responsibility to ensure that no teaching faculty violates the circular instructions. Earlier, the department had also directed the coaching centres to ensure that no government employee is imparting teaching in their coaching centre for which the proprietor has to submit an affidavit duly attested by the judicial magistrate as well. Now, all eyes are on the government and the district authorities of the education department to ensure strict implementation of the circular instruction issued by the government.

## Era of bullying Delhi, exploiting Kashmiris over: Rana

JAMMU: Slamming the opportunistic, deceptive and dubious politics pursued by vested interests in Jammu and Kashmir for decades, Senior BJP leader, Devender Singh Rana today said that the era of bullying New Delhi and exploiting the sentiments of Kashmiris is over, as their machinations stand exposed before the politically conscious and sagacious people.

Rana said some politicians draw sadistic pleasure from isolated incidents of terrorism. They should know that terrorism is on decline and will not be tolerated and the Government of the day will eradicate terrorism from the scope of J&K and destroy its ecosystem whose foundations have already been shaken.

He said the irony of Kashmir has been the dubious role of a section of political class that managed to remain glued to the power in turns at the cost of the interests of the common people. It has not been a new phe-

nomenon for them to deceive the people as they have mastered over the decades by resorting to reactionary politics for their opportunistic agenda. The rhetoric over the restoration of repealed constitutional provisions is nothing but another attempt of underestimating the understanding of the people, which is why they are facing most embarrassing situations in the so-called home turf, he added.

Devender also referred to bullying and blackmailing instincts of the politicians with vested interest and said they adopted these tactics to bully the erstwhile gullible powers in New Delhi in order to remain favourites for holding the reins of the sensitive border state. He said

the scenario has now changed because Delhi now has a strong determined government that wants the common people to be the end beneficiaries of the schemes and funds allotted for Jammu and Kashmir with no role for the 'middlemen' in terms of dubious politicians. He said time has come when the people must exercise their democratic power and choose the public spirited representatives, who will be accountable to them for each of their actions.

Cautioning against the dubious and deceptive political entities, who were attempting to strain Jammu and Kashmir trust with progress, development and harmony as per the cherished agenda of Prime

Minister Narendra Modi's solemn pledge of Sabka Saath, Sabka Vikas, Sabka Vishwas, Sabka Priyas, Rana said the people cannot be dissuaded from their chosen path of being the part of the country's growth story, with equal opportunities to all, irrespective of region, religion or caste.

Rana referred to the fast changing landscape of Jammu and Kashmir, after the political developments of August 2019 which paved the way for implementing all the schemes here like other parts of the country. He said the Union Territory is witnessing discernible transformation in all the economic and developmental sectors with special thrust on encouraging investments. This is a key point for a place where industrial development has not been substantial which has largely impacted the growth and job generation. He also referred to the laudable efforts of pursuing and pushing the developmental initiatives to the next level so that the benefits percolate down to targeted segments of the society in a time bound manner.
