Consequent upon completion of second round of upgradation/allotment counseling for MD/MS/PG Diploma Courses 2022 alongwith HM & NRI quota seats in private College ASCOMS Jammu on 13.11.2022, it is hereby notified that the Board shall conduct the Mop up round for these courses as per the following schedule for filling up of unfilled seats and the seats that remained vacant due to non-joining and resignation of candidates and was received as short fall from various Medical Colleges/ Institutions:-

The eligible and willing candidates have to report in the BOPEE office Jammu / Srinagar for registration and fulfillment of all formalities, from 8:30 am upto 10:00 am on the day and date of counseling.

It is further notified that the candidates may go through the Notification carefully as only the following candidates shall be eligible to participate in the mop up round of counseling and in case of non-fulfillment of the conditions mentioned herein below such candidate(s) are debarred / not allowed to participate in mop up round :-

- The candidates who have not been allotted any seat during the 1st/ 2nd round of counseling shall be eligible to participate in the mop-up round in terms of conditions contained in the Information Brochure.
- The candidates who have been allotted a seat during 1st round of counseling and have joined the college but have not been upgraded during the 2nd round owing to less merit are allowed to participate in the mop-up round. Those candidates who have been allotted seat during the 2nd round of counseling and have joined the college/institution and want to participate in the mop-up round for purpose of up-gradation are also eligible to participate in the mop-up round. Further any candidate who has been allotted a seat during First round of counseling but has not joined against the allotted seat / college shall also be eligible for Mop up round. However, any candidate upgraded during the 2nd round of counseling shall under no circumstances be eligible to participate in the mop-up round.
- The candidates who have been allotted seat in AIQ mop-up-round and have joined the allotted College/Institution shall not be eligible to participate in this mop-up-round.
- The candidates who will be allotted seats during the mop-up round shall have to necessarily join the College / Institution upto the last date of joining as fixed by Board and shall not be allowed to resign. However, such candidates, who do not join the allotted college upto to the prescribed date or resign subsequently, will attract penal provisions of SRO 48 of 2018 dated 30-01-2018 and shall be debarred for 3/2 years as laid down in the said SRO as also reiterated by the Board from time to time. The candidates should, therefore, take a conscious decision about participation in the mopping-up round for allotment of a seat;
- The candidates should go through all the relevant Notifications / Notices along with the e-Brochure notified by the Board with particular reference to the mop-up round of counseling;
- The Board shall first conduct the counseling of reserved category candidates.
- If any reserved category seat(s) remain unfilled due to non-availability of eligible candidates, then those seats shall be converted into OM and shall be filled up accordingly as per merit.
- If any EWS seat(s) remain vacant for want of any EWS candidate, the same shall be allotted to open (OM) candidate on the basis of merit cum-preferences during this mop-up round of counselling.
- The category candidate(s), who may not get a seat in his/her category shall be eligible to participate in the counseling as an OM candidate as per his/her merit subject to the condition that he / she falls within the cut off score of OM.
- The candidates who have already resigned against the seats allotted to them during first and second rounds or even before mop-up-round of counseling shall not be eligible to participate in the mop up round of counseling.
- The eligible candidates, who have not been upgraded but have joined ASCOMS under OM Quota / Management Quota and are desirous to participate in the mop up round against Hindu Minority / NRI Quota seats available in ASCOMS can do so subject to the condition that they are eligible for HM / NRI Quota. The seat matrix shall be made available on the website of the Board in due course of time.
