# CRIME REPORT

## Four narco-smugglers nabbed with heroin

JAMMU: Continuing its endeavour to eradicate menace of drugs, Police on Thursday arrested four drug peddlers in different cases and recovered heroin like substance from their possession.

As per details, a team from Police Station Rannagar led by SHO Rannagar Insp Pushpinder Singh under the supervision of Addl. SP Udhampur Anwaar Ul Haq and SDPO Rannagar Dr Bhishm Dubey, while patrolling in main Bazaar of Rannagar, apprehended a suspect, later identified as Sanjeev Kumar alias Sanju, son of Mansa Ram, resident of Ward-8, Rannagar. On frisking of suspect, police recovered 10.27 gm heroin like substance from his possession. He was arrested and FIR No. 148/2022 under sections 8/21/22 of NDPS Act was registered against him in Police Station Udhampur. In another case, a party of Police Post Roundmail led by PSI Akhilesh Khajuria Incharge Police Post Roundmail and assisted by SHO Udhampur Insp Raghbir Singh under the supervision of DySP Hqrs Sahil Mahajan intercepted a suspect namely Abhishek Thakur, son of Mohan Singh, resident of Near CEO office Dandyal, Udhampur and recovered 6 grams Heroin like substance from him. He was arrested and FIR No. 498/2022 under sections 8/21/22 of NDPS Act was registered against him at Police Station Udhampur. In another incident, a party from Police Station Samba led by SHO Samba Insp. Deepak Jasrotia assisted by PSI Rajat Sharma under supervision of DySP Hqrs Samba, Mohd Usman during surprise Naka near DC Office Chowk, Nandani Hills, Samba, intercepted a Scooty (JK21F/1891) for checking. During checking, approximately 2.5 gm heroin like substance was recovered from rider. On questioning, the accused disclosed his identity as Abhishek Attri, son of Dayal Parshad, resident of Samba. The accused was arrested on the spot and FIR No 280/2022 under sections 8/21/22/25 of NDPS Act was registered against him at Police Station Samba.

Meanwhile, a party of Police Station Miran Sahib headed by Insp Zaheer Mushtaq under the supervision of SDPO R S Pura Surinder Singh and SP Hqrs Rannish Gupta estab-



lished a Naka at Dak Bungalow for checking / frisking of vehicles / pedestrian. During checking, a car (JK21H-3871) was stopped for checking on suspicious grounds. During questioning, the driver disclosed his name as Gurbpreet Singh alias Guppi, son of Late Ranjeet Singh, resident of Lower Gadigarh, Tehsil & District Jammu. 6 gm Heroin (Chitta) like substance and an electronic weighing machine was recovered from his possession. FIR No. 156/2022 under sections 8/21/22 /60 of NDPS Act was registered against him at Police Station Miran Sahib.

## Three booked under PSA

## 2 drug-peddlers arrested, contraband recovered

As per the details, a party from Police Station Rajpora at a checkpoint established at Pachhar intercepted two suspects. During checking, 1 Kg dried Cannabis was recovered from their possession. The accused were identified as Aqib Fayaz Wani, son of Fayaz Ahmad Wani, resident of Bannoo and Zubair Ahmad Wani, son of Bashir Ahmad Wani, resident of Ichgooz Pulwama. They were arrested and shifted to police station where they remained in custody. Accordingly, FIR No.96/2022 under relevant section of was registered at Police Station Rajpora and investigation started.
