Subject:- Balance work for construction of drainage system Nagrota (under Languishing Programme LUP-1325).

The above said work was allotted to you vide this office No:SEJ/DB/8845-48 dated 19-11-2020, with the condition that the work was to be started within 07 days from the date of issue of allotment and completed within 01 year, but you have completed a portion of the work in the month of September 2021-22 for which you have received a payment of Rs.44.00 lacs in the month of March 2022-23. As you were directed many times to resume the remaining works but all in vain. As reported by the Assistant Executive Engineer PWD(R&B) Sub-Division Nagrota Jammu vide his No:AEE/NSD/607-09 dated 26-08-2022 and No:AEE/NSD/972-74 dated 15-11-2022 that after many requested/ directions given to you through Telephone & review meetings time to time. Now, as directed by the Director Urban Local Bodies Jammu after onspot visit it was decided to resume and complete the projects within 02 months but you have not responded nor resume the work. Again a meeting was conducted by Worthy Chief Secretary J&K UT in the month of ending October 2022, it was decided to resume the work within a week's time to terminate the contract and put to fresh tenders.

You adopted lackadaisical approach towards resuming the above said project which is causing huge loss to public as well as government exchequer.

You are directed to execute the work immediately under intimation to this office, failing which your allotment of contract shall be recommended to higher authorities for cancellation and fresh tenders may be floated at your risk & cost and legal action may be initiated against you without any further intimation from this office.
