Consequent upon the issuance of Notification No. 085-BOPEE of 2022 dated 17-11-2022 the candidates belonging to Hindu Minority/NRI categories submitted their documents for respective categories up to 22nd of November, 2022. As a prerequisite the said documents of the candidates were checked and verified on 10th of November, 2022 by the Committee constituted for the purpose. After the verification of documents submitted by the candidates it has been found that all the candidates (Annexure-A) who have applied under Hindu Minority Quota are eligible for consideration under the said Category.

While as the candidates who have applied under NRI category as mentioned in (Annexure-B) to this Notice, it has been found that documents of only 12 (twelve) candidates out of the total of Twenty-three (23) are complete in all respects, whereas documents of 10(ten) candidates have been found deficient and 01(one) candidate is rejected as mentioned against each in the Annexure-B to this Notice. The list of candidates whose documents are deficient in one way or the other is available on the BOPEE website www.jkbopee.gov.in as Annexure-B to this notice. The candidates in their own interest are advised to clear the deficiencies by or before 28-11-2022 (till 01:00 p.m.).

In Pursuance of rules contained in Treasury Code, the Pensioners/ Family Pensioners drawing pension through treasury/ Bank are required to produce Life Certificate once in a calendar year i.e by ending November. It has been brought to the notice of Finance Department that a large number of pensioner/ family pensioners have yet to submit their life certificate, as such pension for the month of November 2022 and onward can not be disbursed by the bank/ Treasury.

In order to avoid inconvenience to the pensioners/ family pensioners, date for submission of life Certificate is hereby extended upto 23-12-2022, All the pensioners/ family pensioners are therefore advised to furnish their life Certificate to the concerned Bank/ Treasury by or before 23-12-2022 failing which disbursement of pension for the month of December & onward shall be stopped. During this extended Period, the Pension will continue to be paid by the pension disbursing authority (PDAs), uninterrupted.

For convenience of pensioners/ family pensioner having a valid Aadhar, life certificate can also be submitted digitally through the "Jeevan Pramaan" Portal.
