## Final electoral roll of J&K published with highest-ever net increase of 7.72 lakh voters

JAMMU: The final electoral roll of Jammu and Kashmir was published on Friday with the highest-ever net addition of more than 7.72 lakh voters, officials said.

The final electoral roll has a total of 83.59.771 electors --42,91,687 males, 40,67,900 females and 184 third gender -- Joint Chief Electoral Officer of Jammu and Kashmir Anil Salgotra said.

The release of the electoral roll paves the way for holding of Assembly polls in the Union Territory, the first since Article 370 provisions were abrogated and Jammu and Kashmir was bifurcated into Union territories in

"There has been a net increase of 7,72,872 electors in the final electoral roll, i.e. a 10.19 per cent net increase of the registered electors over the draft roll," he said.

The highest number of additions during a special summary revision (SSR) was

less than two lakh earlier.

"This was for the first time in the history of Jammu and Kashmir that more than 11 lakh names were included in a single SSR period," Salgotra said.

During this period, a record 11,40,768 claims were received through Form 6 for inclusion of names in

# India rectifying past mistakes, celebrating unsung heroes: PM

NEW DELHI: Minister Narendra Modi on Friday said India was correcting its past mistakes by celebrating its heritage and remembering its unsung bravehearts who were lost in the pages of history written as part of a conspiracy during the colonial era.

Addressing the 400th birth anniversary celebrations of legendary Ahom general Lachit Barphukan, Modi said the history of India was not just about slavery but also about its warriors and it was important that the collective sense of history was not limited to a few decades or centuries.

"The history of India is not just about slavery. The historv of India is about emerging victorious, it is about the valour of countless greats. India's history is about standing against tyranny with unprecedented valour and courage," he said.



On the issue of collegium, the CJI said: "Finally, criticism about the collegium. I thought I will reserve the best for the last. No institution in a constitutional democracy is perfect. But we work within the existing framework of the Constitution as it is interpreted and given to us. All the judges of the collegium including me, we are faithful soldiers who implement the Constitution. When we talk of imperfections, our solution

is to work our way within the existing system.

He said getting good people in the judiciary and paying them high salaries would not reform the collegium system.

"The president (of SCBA) raised a query about good people. Getting good people to enter the judiciary, getting good lawyers to enter the judiciary is not just the function about reforming the collegium. Getting to be judges is not a function of how much salary vou give judges. However high you pay judges, it'll be a fraction of what a successful

## J&K to see major boost in business, tourism investments: Officials

SRINAGAR: The Jammu and Kashmir administration is working to boost business investment and enhance income of the local population by simplifying rules and procedures, and digitising records, senior officials said.

## DB directs authorities to ensure completion of projects for public convenience, de-congestion of traffic in Jammu

JAMMU: In a Public Interest Litigation (PIL) filed by Citizen Forum regarding fly-over project from Shakuntla to Janipur proposed in 2008, which was abandoned for some extraneous reasons, Division Bench of Jammu & Kashmir and Ladakh High Court comprising Chief Justice Ali Mohammad Magrey and Justice Vinod Chatterji Koul after hearing Adv Aditya Sharma for PIL whereas Advocate General D C Raina with AAG Ravinder Gupta for the UT, disposed of the PIL with directions that the authorities will ensure completion of project for the convenience of public and for decongestion of traffic in

When the PIL came-up for hearing, DB observed that the respondents have given the details about the approach for widening of the aforementioned roads from year 2007-2008 at a project cost of Rs 18.04 crores. DB further observed that respondents from time to time had taken stand that the subject matter of widening of roads, construction of flyovers etc., falls within the scope and powers of the Jammu and Kashmir Economic Reconstruction Agency (in short ERA). It has been further stated that looking to the traffic problems, widening of the B C road was envisaged to make it 8-lane road. However, since the said

project involved acquisition of about 53 Kanal of land as also re-settlement and relocation, the same translated into huge costs. The projects for the development of the city have also been stated to be financed by Asian Development Bank (ADB), wherever the land acquisition and resettlement issues are settled on the guidelines issued by the Government from time to time.

DB further observed that during the pendency of the instant PIL filed Citizens Forum through its President R K Chadha, the Court noticed that proposal with regard to widening of B C road-Amphalla-New Plot-Janipur road was
