## Three absconders arrested after 8 years

**RAJOURI/UDHAMPUR:** Police on Saturday arrested three absconders who were wanted in several cases and absconding from last 8 years.

As per details, an absconder namely Mohd Maqbool, son of Mohd Yousaf, resident of Kandji, who was evading arrest in FIR 80/2014 was arrested. Another absconder namely Mohd Fareed, son of Abdul Rashid, resident of Muradpur, Rajouri who was evading arrest in FIR 117/2017 was also arrested. Both accused shall now be produced before the Court for further course of action. The arrests were made by police teams headed by SHO Rajouri Insp Fareed Ahmed under the supervision DySP Hqrs Rajouri Chanchal Singh.

Meanwhile, another absconder namely Pappu Ram, son of Shankar, resident of Satyalta, Udhampur, wanted in FIR 87/1985 under section 379 of RPC registered at Police Station Udhampur and was evading arrest since long. Court had issued warrant under section 512 CrPC against him and on specific information, a special team of Police Station Udhampur headed by Insp Raghubir Singh SHO Udhampur, arrested absconder and produced him before the Court of Chief Judicial Magistrate Udhampur for judicial determination.
