Procedure for Selection.

1. Candidates will be selected purely on Academic/Technical Qualification merit basis & points of Experience.

2. Final merit of the candidate shall be framed on the basis of total points obtained out of 100 points.

3. List of selected candidates shall be published in local newspaper.

4. The age limit however is determinable with reference to the 1st of Jan of the year in which the Advertisement is made i.e. 01-01-2022.

5. Only such qualification shall be considered which the applicant is in possession on the last date of receipt of applications.

6. The number of applicants for the viva-voice shall be short listed in the ratio of 1:5 on pro rata basis.
