

UDHAMPUR: As soon as the news of the thumping victory of its candidate from Mumbai Andhra seat was received, the leaders of Shiv Sena Jammu and Kashmir unit distributed sweets and danced fiercely on drums.

Congratulating all Shiv Sainiks including party candidate Rutuja Lat ke, Party Chief Uddhav Thackeray and Youth National President

Aditya Thackeray, Manish Sahni said that whenever the Shiv Sena of the venerable Balasaheb Thackeray has to face challenges, with the support of the public we have come out stronger. Sahni said the BJP candidate had already withdrawn his nomination fearing his defeat.

This is the first time under Modi and Amit Shah that the BJP has stepped back in view of the strength of Shiv Sena. Sahni said that as per the orders of the party chief, the Shiv Sena has geared up to give a tough fight to the BJP even outside Maharashtra. - (a) \*Hindu Minority (HM) seats under management quota shall be filled up from the NEET-PG qualified candidates belonging to Hindu Religion only with the condition that they shall produce latest relevant document/certificate issued by the concerned competent authority.
- (b) \*\* NRI seats shall be filled up on the basis of merit cum preferences provided the necessary NRI documents are complete in all respects.
- Only such candidates shall be considered under NRI/Hindu Minority quota who are:
- (i) Domicile of J&K;
- (ii) have applied under NEET-PG 2022 and have qualified; and
- (iii) have been found eligible to participate/compete against the J&K seats;

**The eligibility criteria for competing under NRI quota seats shall be as under:-****(Category 1): Where applicant himself/herself is NRI and family originally belongs to J&K.****(Category 2): Children/Ward of NRI who originally belong to UT of Jammu and Kashmir.**

Any other condition as notified by the Government of India/ Government of J&K or any direction given by the Hon'ble Supreme Court, of India, in this regard to compete for such seats.

- (ii) NRI certificate issued by the Ministry of External Affairs, Government of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;
- (iii) NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India;
- (iv) Copy of Indian Passport;
- (v) Copy of Income Tax Return filed in India, if any;
- (vi) PAN Card, if any; and
- (vii) Domicile Certificate of the candidate belonging to J&K.
- (viii) Any other document as may be required by the Board to its satisfaction.

**Category No. 2:**

- (i) NEET PG Score Card-2022;
- (ii) NRI Sponsorship Letter;
- (iii) Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
