## J&KPDD holds 2-day capacity building workshop for engineers

JAMMU: The J&K Power Development Department with the support of Power Finance Corporation PFC Ltd. (a CPSU of Ministry of Power, Government of India), on Monday organised 2-day Capacity Building Workshop on the topic "Advanced Technological Intervention in Power Sector" for Engineers of the Power Development Department in the run up to the implementation of Revamped Distribution Sector Scheme (RDSS).

The workshop, held in Holy Town of Katra, was attended by all the senior officers of the Power Development Department

from Chief Engineer to Assistant Ex. Engineer. The PFC Ltd. has been nominat-ed as nodal agency for faci-litating the implementation of the Revamped Distribution Sector Scheme (RDSS). The scheme envisages Reduction of AT&C losses to pan-India levels of 12-15% by 2024-25; Reduction of ACS-ARR gap to zero by 2024-25 and Improvement in the quality, reliability and affordability of power supply to con-sumers through a financially sustainable and operational-ly efficient distribution sec-tor.
