The firing targeting Border Outposts in the district is the third ceasefire violation n 24 days by Pakistan Rangers along the IB in the Jammu frontier.

BSF Head Constable Lal Fam Kima suffered injuries and was evacuated to a local nospital. He was later moved to the GMC Hospital in Jammu, the officials said. The Head Constable succumbed to injuries, they said and that the 50-year-old was resident of resident of Aizwal in Mizoram.

His body has been shifted to GMC Hospital's mortuary for postmortem.

"During night intervening 8/9 Nov 2023, Pakistan Rangers resorted to unprooked firing in Ramgarh area which was befittingly responded to by BSF troops," the Border Security Force (BSF) said in a statement.

Ramgarh Community Health Centre Block Medical Officer (BMO) Dr Lakhwinder Singh said that one BSF jawan was injured in Pakistani firing and

reported to the centre for treatment around 1 am. Mohan Singh Bhatti of Jerda village said that the firing started around 12.20 am and later escalated into shelling. "A fear psychosis is prevailing along the IB due to

firing and shelling," he said. Lieutenant Governor Manoj Sinha and Special Director General of BSF, P V Ramasastry paid homage to the martyred BSF Head Constable.

Apart from them, Chief Secretary A K Mehta, Home Secretary R K Goyal, IGP Anand Jain, IG BSF D K Boora and Divisional Commissioner Ramesh Kumar also paid tributes to the BSF jawan, Lal Fam Kima, at the frontier headquarters, Paloura camp, in Jammu.

During wreath-laying ceremony, he was given full military honours by sounding of buggle and last salute. The jawans raised slogans hailing him.

The mortal remains of Kima would be sent to his hometown Aizwal for the last rites with full military honour.

Treva had also received cross-border shelling on October 28. Speaking to reporters, Sarpanch Balbir Kaur said that every person living along the border is sad due to the BSF head constable's death. of winter, snowfall, and closure of tracks every year. But, we are alert. I visited the LoC (on Wednesday), met my troops and Army officers. They are alert and if there is any infiltration attempt, we will foil it," the DG BSF told reporters.

"But, we foil their designs every year and that is happening this year too. They are trying, but their designs are not succeeding. A terrorist was killed in Shopian in an encounter today. They are attacking common people, this is a sign of desperation," he added. Asked about the ceasefire violation in Samba district of Jammu where a BSF trooper was injured, the DG said, "Pakistani troops attacked our posts twothree times and have targeted our jawans"

"But, our forces are alert and have retaliated very well. There is perhaps severe damage on that side, but it is not confirmed yet. A BSF trooper is injured, he has been hospitalised," he said.

The BSF head constable later succumbed to injuries.

To a question whether such firing incidents from across the border would have an impact on the ceasefire, Agrawal said it (firing) has been happening for the past two weeks, but we do not know the reason behind it.

"We are discussing it and once we get to know the reasons, we will devise a strategy (to counter it)," he said.

"It is difficult to say as to what will happen. We do not start it from our end, but, whenever it takes place, we effectively retaliate it," he replied to a question whether such incidents would escalate the situation.

To a question if the firing was a cover for pushing in more infiltrators, Agrawal said along the International Border, there is a less chance of infiltration, so the firing is something new there, except for Arnia sector where it used to happen earlier as well. Asked if there is any major activity taking place across the border, the DG said "no, there is no such activity, but, whatever activity they undertake, they will do it secretly. They will not want it to be noticed".

Earlier, the DG inspected the passing out parade and attestation ceremony of five batches of recruits. The trainees hail from eastern and southern India including 204from Odisha, 208 from Andhra Pradesh, 112 from Kerala, and 75 from Telangana.

while in power at the Centre or in states," Modi alleged.

The PM asserted that India's stature is rising in the comity of nations, but the Congress is not comfortable with this global ascendancy.

"Due to tactics of the Congress, we saw a period of terror and anarchy in the coun try. Anarchy got encouragement. The spirit of nation-building that existed at the time of independence was crushed by the Congress due to its devotion to one fami

The Congress, wherever it ruled, created a new record in corruption, he alleged. "Due to this mentality of the Congress, it got wiped out from many states one after the other. Its traces are disappearing. The Congress has been yearning for a majority in Madhya Pradesh for two decades," the BJP's star campaigner maintained. Modi claimed the Congress has divisive traits.

"And where there is division, vision is not possible," he said and added that in contrast the BJP is working with spirit of "Ek Bharat Shreshtha Bharat" (One India Great India).

The PM alleged the Congress only empowered sons and daughters of certain fam ilies, while "the BJP is working for the welfare of all daughters".

Modi maintained the Grand Old Party has no solutions to the country's problems "Because of the Congress, the country's problems have become more serious, espe cially the loot of the poor. One of its Prime Ministers once admitted that out of Re 1 sent from the Centre, only 15 paisa reached the beneficiary," said the BJP's star campaigner.

"But who was looting this 85 paise? It was panja (hand)," he remarked, apparent ly referring to the Congress poll symbol 'hand.'

Modi was apparently making a reference to then-PM Rajiv Gandhi's remark made in the 1980s that only 15 paise of every Re 1 released by the Centre reached the end beneficiary.

However, the BJP has found a solution to plug leakages in welfare schemes by cre ating a trinity of 'Mobile, Aadhaar and bank accounts' (Jan Dhan), he said.

The Centre has transferred Rs 2.60 lakh crore under the PM Kisan Sammar Nidhi scheme directly into the bank accounts of beneficiaries, bypassing middlemen stated Modi. During the Congress regime, only 6,000 houses were sanctioned under the Pradhan Mantri Awas Yojana (urban), while the BJP's 'double-engine' govern ment (saffron party in power at the Centre and in a state) approved construction of 10 lakh homes in Madhya Pradesh, he said.

NEW DELHI: In a significant verdict aimed at fasttracking trials in more than 5,000 criminal cases against lawmakers, the Supreme Court on Thursday directed high courts to set up a special bench to monitor cases for their speedy disposal, saying these cases have a "direct bearing on our political democracy".

Issuing a slew of directions to high courts, district judges and special courts designated to hear matters related to lawmakers, the top court directed that criminal cases members against Parliament, legislative assemblies and legislative councils be given priority and the trials be not adjourned in such matters except "for rare and compelling reasons".

"These cases have a direct bearing on our political democracy. Hence, there is a compelling need to make every effort to ensure that these cases are taken up on

monitor criminal trials against lawmakers priority and decided expeditiously.

SC asks high courts to set up special bench to

"Confidence and trust of the constituency in their political representative, be it an MP or an MLA, is necessary for an interactive, efficient and effective functioning of a parliamentary democracy. However, such confidence is difficult to expect when figures, as indicated in the above referred table, loom large in our polity," said a bench comprising Chief Justice Chandrachud and justices P S Narasimha and Manoj

There are as many as 5,175pending as of November, 2022 against MPs and MLAs across the

"Of these, cases that are pending for more than 5 years are as many as 2,116, which figure is more than 40 per cent of such pendency. This is a large number," the CJI said in the 15-page judgement.

"The learned Chief Justice of the High Court shall register a suo motu case titled as 'In Re Designated Courts for MPs/MLAs' to monitor early disposal of criminal cases pending against the members of Parliament and the

legislative assemblies," the

judgement said.

The bench said that multiple local factors made it difficult for the top court to "frame uniform or standard guidelines for trial courts across the length and breadth of this country" and it left the issue of ensuring speedy trial to the high courts as they have the power of superintendence over the

trial courts. "Under Article 227 of the Constitution, the high courts are entrusted with the power of superintendence over the subordinate judiciary. We deem it appropriate to leave it to the high courts to evolve such a method or apply such measures that they deem expedient for an effective monitoring of the subject cases," the bench said.

The suo motu (on its own) case may be heard by a special bench presided by the chief justice (of the high court) or judges assigned by him to the special bench that may list matters at regular intervals as felt necessary, it

"The high court may issue such orders in all directions as unnecessary for expeditious and effective disposal. The special bench may consider calling upon the advocate general or the public prosecutor to assist the court," the bench directed. It said that a high court

may ask the principal district and sessions judge to bear the responsibility of allocating the subject cases to such court or courts, as is considered appropriate and effective. "The high court may call upon the principal district and sessions judge to send reports at such intervals as it is considered expedient.
