

CUJ holds 8th Court Meeting

JAMMU: The 8th Court Meeting of the Central University of Jammu (CUJ) was convened on the university campus under the guidance of Chancellor, Ambassador G. Parthasarathy. The meeting commenced with a welcome from Vice Chancellor Prof. Sanjeev Jain, who expressed gratitude to the Chancellor and other Court members for their dedicated efforts to support the university's growth. The Chancellor conveyed his satisfaction with the university's progress in infrastructure, construction, and academic development. The meeting agenda included discussions on the university's perspective plan with a focus on construction activities, an action report from the previous Court meeting, and the presentation of annual reports and financial accounts.
 Notably, the HEFA project for substantial university building construction was reviewed. The Registrar Prof. Yashwant Singh took up the agenda item of Court and underscored university perspective plan where-in construction activities have been prioritized.
 The Vice Chancellor informed

the Court about various reforms taken in the University which are adoption of MOD-DLE LMS which is worldwide accepted M.L.S: Degrees to be issued to the students in NAD (National Academic Depository) so that they can access the degree online: Internship of students and Indian Knowledge Systems courses for teaching and research. Further Vice Chancellor Prof. Jain highlighted that four buildings are simultaneously being constructed in the university along with the sports facility basketball and badminton court.
 Further the Vice Chancellor informed the Court that Section-8 Company CUJ Site Council is being formed to foster research and development and entrepreneurship to spawn knowledge intensive that would develop relevant innovations useful to the society as a whole. Other achievements in the pipeline are Community Radio, Nano Satellite to be launched and moving towards the NAAC accreditation and other international accreditation bodies. The meeting was attended by Deans, Directors and Officials of the University.


