#### SIA conducts raids...

(SIA) said. Special teams of the agency conducted searches at 10 locations in

"In continuation to searches conducted on November 8, the SIA, Kashmir, conducted searches at multiple locations, including in two locations in Srinagar, one in Anantnag and seven in Pulwama," it said.

According to the SIA, the searches were conducted in the early hours as part of an ongoing investigation in a case (FIR No 08/2023) registered at SIA Kashmir police station. The cash laundered was to be used to fund terrorism and secessionsm in the Union Territory

"This is a terror-funding case in which money amounting to Rs 85 crore has been aised and laundered through covert channels, which is suspected to be used in funding terrorism and secessionism in the Union Territory of Jammu and Kashmir," the agency said.

Friday's operation marks the second round of searches in the case. On Wednesday, the SIA conducted extensive searches in New Delhi and various districts of the Kashmir Valley, it said. The SIA's special teams have recovered incriminating material in the form of electronic gadgets such as mobile devices, laptops and SIM cards, and documents such as passports, cheques, passbooks and credit/debit cards, etc.

activities appear to be deeply entrenched, leading to a severe impact on the revenue collection system of J&JK UT. The fraudulent activities include illegal issuance of agriculture certificates, which are essential documents in the purchase and sale of agricultural land. These certificates are being issued illegally, often to individuals with no genuine connection to agriculture.

Moreover, some certain unscrupulous individuals, possibly in association with employees of the Sub Registrar's Office, are fraudulently re-using stamp papers multiple times, the complaint stated.

After preliminary investigations, the CB states that this not only compromises the legal integrity of land transactions but also inflicts substantial financial losses on the revenue department and the state exchequer.

The modus operandi of this organized gang involves a network of individuals, including certain Revenue Department officials, property dealers, stamp paper vendors, commission agents, and other intermediaries. It is evident that these individuals are operating with a high degree of coordination, facilitating the issuance of agriculture certificates in exchange for substantial sum of money, thereby siphoning off state funds.

"The India-US defence relationship has evolved into a strategic partnership characterised by mutual trust, shared values and a growing recognition of com mon interests in maintaining regional and global security," Singh said in his open ing comments at the bilateral talks. "We increasingly find ourselves in agreemen on strategic issues, including countering China's aggression, promoting a free and open Indo-Pacific and addressing regional security challenges," he added.

We share a focus on maritime security in the Indo-Pacific region. Recognising the criticality of safeguarding vital sea lanes and promoting stability, our teams are working on substantive outcomes," the defence minister said.

He said India and the United States are charting new pathways of cooperation by pursuing stronger defence, industrial engagement, easing of technology restric tions, boosting ties in the maritime domain and aiming to ensure resilient supply chains in all domains. Singh and Austin drew up an agenda for future joint work for their teams, the defence ministry said.

At a media briefing after the talks, Austin said the two sides discussed the ris ing security challenges posed by China. "We are working together on a number of things going forward. Sessions Judge Jammu Virender Singh Bhou after hearing APPManzar Khavam for the UT, observed that Murder herein is outcome of dowry demand and wife being less educated and sick, the convict wanted to get rid of her. A distinction should be made between a dreaded and hardened criminal and ordinary criminal while sentencing the convict. It is not only the duty of the Court but social and legal obligations are clearly enjoined upon it to impose adequate punishment according to law while taking into consideration not only the crime, but also the criminal. Furthermore, deterrence and reformation are primarily social goals, which make deprivation of life and liberty reasonable as penal panacea. Retributive theory as on day is no longer valid. Sentence of death is only deterrent and preventive, but sentence of imprison-

With these observations, the Court held that the convict, namely, Aman Kumar, therefore, is sentenced to undergo rigorous imprisonment for life for the commission of offence under section 302 RPC and pay a fine of Rs. 10,000/-. In case of default of payment of fine the convict shall undergo further simple imprisonment of months. He is further convicted for the commission of offence under section 498-A RPC to undergo rigorous imprisonment of 2 years and pay a fine of Rs. 1000/- and in default of payment of fine he shall undergo simple imprisonment for one month.
