Whereas, Rule-11 of SRO 252 J&K Economics & Statistics (Subordinate) Service Recruitment Rules, 1989, provides for maintenance of updated and final seniority of members of the service strictly as per J&K Civil Services (Classification, Control & Appeal) Rules 1956;

Whereas, the Directorate of Economics & Statistics has notified the tentative seniority list of Junior Statistical Assistants viz. State Cadre, Divisional Cadre Jammu and Divisional Cadre Kashmir as on 01.04.2017 vide Circular No. DES/Seniority/141-B(Adm)/1515-20 dated 14.06.2017. No. DES/Seniority/141-B(Adm)/1509-14 dated 14.06.2017 and No. DES/Seniority/141-B(Adm)/1503-08 dated 14.06.2017 respectively;

Whereas, the tentative seniority list of Junior Statistical Assistants viz. UT, KDC and JDC as on 20.06.2022 was notified vide Circular No. 09-DES of 2022 dated 20.06.2022 but the same was not finalised pending genuineness of qualification certificates of candidates from the concerned educational institutes;

Whereas, the General Administration Department vide Circular No. 09-JK (GAD) of 2022 dated 08.03.2022 has clarified that the employees appointed to UT of Ladakh vide Government Order No. 1212-JK (GAD) of 2021 dated 15.11.2021 shall be excluded from 'Seniority List/Eligibility list'. As a result the following seventeen (17) Junior Statistical Assistants are to be excluded from the Seniority List and shall not be considered for promotions in the UT of Jammu and Kashmir w.e.f. 15.11.2021:-

Whereas the verification process of genuineness of qualification certificates of the candidates has been completed and the requisite action as warranted under rules has been taken/ is being taken against the candidate (s) who have been found at fault for producing forged/ fake qualification certificates at the time of appointment/ selection process:

Whereas, Planning, Development & Monitoring (Administrative) Department vide letter no. PDMD-Adm/283/2023 dated 20.09.2023 has authorised the Directorate of Economics & Statistics to issue the Tentative Seniority List of Junior Statistical Assistants (JSAs) after deleting the names of JSAs whose services have been terminated ab-initio and slot for one more candidate be kept reserved till the case is disposed of by the Administrative Department;

Whereas, the details of i/c Jr. Statistical Assistants (KPOs - UT/KDC/ JDC placed as i/c JSA on OPG basis) have not been included in the tentative seniority and their Seniority shall be fixed subsequently at appropriate place after their regularization/ confirmation by the DPC in their respective cadres;

Whereas, a number of changes have taken place in the seniority list maintained by the Directorate by effecting appointments, resignations, apportionment of manpower/ posts to Union Territory of Ladakh and cancellation of appointments etc and as such need has been felt to revise and update the seniority list; and

Whereas, the Departmental Promotion Committee (DPC) in its meeting held on 15.12.2021 has, among other things, taken the following decision:-

"The Directorate will issue the final Seniority list of all categories of posts in the Ministerial/ Technical Cadre of J&K Economics & Statistics (Subordinate) Service after inviting the necessary objections."

Now, therefore, the Tentative Seniority List (cadre wise) of Junior Statistical Assistants borne on the J&K Economics & Statistics (Subordinate) Service as on 01.11.2023 is hereby notified as per Annexure A-I, A-II & A-III to this Circular for inviting objections, if any, from the members of the service.

After twenty one days, no objection shall be entertained.
