4. Bidders must quote for all the particulars of the item in the Technical Bid and in the price schedule/BOQ of financial bid. The bids of Bidders who will not quote for all the particulars for any item in technical and financial bids shall be liable to be rejected at the discretion of the Employer keeping in view the interest of the JPDCL.

5. All the e-Bids must be accompanied by the scanned copy of EMD in the form of CDR/FDR/Bank Guarantee only from any Nationalized/Scheduled bank only pledged to Executive Engineer (Distribution), Electric Division Vijaypur, JPDCL. No Interest shall be payable on Earnest Money deposited with the Department.

4. The complete bidding process shall be online from 13.11.2023 to 21.11.2023 04.00 PM and shall be opened on 22.11.2023 at 3.00 PM or on any convenient date in the office of Executive Engineer JAL SHAKTI (PHE) City Division No.II Jammu. In case office happens to be closed on the date of opening of the bids due to holiday, bids shall be opened on the next working day or any other date convenient to the tender opening authority, particularly keeping in view the ongoing restrictions on account of COVID-19.

5. If any bidder quotes rates below than 25%, of the advertised cost his bids shall be rejected.

6. The performance security shall be forfeited, if any bidder withdraws his onlinebid/tender during the period of bid validity or fails to start the work within stipulated period.

7. No Engineer of Gazettedrank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without permission of the Government. The contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as foresaid before submission of the tender or engagement in the Contractor's Service.

8. The contractor or intending bidder are advised to understand the nature of job advertised in E NIT. He may contact this office for any further discussion in case of an doubt.

9. If any, typographical error/ omission in respect of rate/ unit is found in the E NIT it shall be corrected as per sanctioned schedule of rates 2022.

10. Any item other than the advertised, required to be executed at site, shall be allowed to be executed by the contractor at par with the SSR 2022 Rates. .

11. The work identified for execution shall to be started within 07 days from the date of allotment. Delay in completion of particular work within the stipulated period shall attract a penalty of upto 10% of the contract value for delay upto one month and @ 20% for the period exceeding one month shall be imposed upon the concerned contractor
