JAMMU: A meeting of line departments was held here on Monday to discuss the arrangements for 554th Parkash Ustav of Guru Nanak Dev Ji to be celebrated on November 27 this year.

Chaired by Additional Deputy Commissioner Ansiya Jamwal, the meeting was attended by representatives of District Gurdwara Parbandhak Committee Jammu and the district officers of line departments.

It was informed that the main congregation will be held on November 27 from 10 am to 5 pm at Gurudwara

Maharani Chand Kaur in the city. Akhand Path will also start on November 25 at the same place.

The representatives of District Gurdwara Parbandhak Committee informed the chair about the different issues that require necessary attention of the departments for the smooth and peaceful celebration of the auspicious occasion.

The chair directed the departments to make arrangements for adequate security, traffic regulation, cleanliness, sanitation, water supply, electricity, fire safety at the main function.

It is hereby notified for the information of all the concerned candidates that the National Commission for Indian System of Medicines, Ministry of Ayush, Government of India, vide communication No. AIAPGET/COE/2023 dated 09.11.2023 has reduced the minimum qualifying percentile criteria by five percentile criteria across all categories for admission to UG courses under Ayush for academic year 2023-24 and the Ayush Admissions Central Counseling Committee (AACCC) vide communication No. AA-11013/1/2023-EP- I dated 13.11.2023 has notified conduction of Special Stray Vacancy Round as an additional round for admission to seats in Government/Private Colleges/Institutions and the last date of admission in these courses for academic year 2023-24 is 30th November, 2023. 2. The candidate(s) who have been allotted seat/college during Mop Up Round of counselling but have failed to join against the said seat/college, he/she shall not be eligible to participate in the Stray Vacancy Round of counselling under any circumstances.

Pursuant to Notification No. 067-BOPEE of 2023 dated 20.08.2023, the Board conducted the First Round of Counseling from 17.08.2023 to 19.08.2023 for admission to General Nursing and Midwifery (GNM) Lateral Entry Course-2023 in Government / Private Colleges/Institutions of UT of J&K. In order to fill up the shortfall seats, including the seats which have remained unfilled during the First Round of counseling, it is hereby notified that the Board shall conduct 2nd / Mop Up Round of (Physical) counseling for admission to GNM (Lateral Entry) Course 2023 simultaneously at BOPEE office Jammu / Srinagar as per following schedule:-

However, the reserved category candidates shall also be eligible to participate in the counseling process as an OM candidate, if otherwise eligible in OM on both days.

The candidates who have not participated earlier in the counseling process shall have to deposit non refundable counseling fee of Rs. 1000/- through POS Machine available at BOPEE office Jammu/Srinagar through Debit/Credit cards. Any candidate who fails to deposit the counseling fee shall not be allowed to participate in the counselling. The deposition of the counseling fee by the candidate(s) shall not confer any right to the candidate(s) that he/she shall claim for allotment of seat. The seats shall be allotted strictly on the basis of merit cum preferences and subject to availability of seats.

In order to fill maximum number of seats & to accommodate more candidates, the Board has decided to lower the bench marks from 20 to 10 marks for this round of counseling and hence those candidates who have secured 10 marks in Common Entrance Test conducted by the Board shall be eligible to attend counseling as per the above schedule.

All the candidates who are participating in this round of counseling are advised to bring along the following documents in original on the day of their counseling failing which they shall not be allowed to attend the counseling:

- i) Domicile certificate,
- ii) Marks card of FMPPHW/MMPPHW/ANM Diploma,
- iii) D.O.B as per matriculation certificate,
- iv) Valid Category Certificate, wherever applicable,
- v) Medical Fitness certificate.

The Board shall first conduct the counseling of CDP/ALC/IB/STK/STL/RBA Reserved Category candidates during 2nd/Mop Up Round of counseling process and if any seat of any reserved category remains vacant due to non availability of eligible reserved category candidates, then the same category seat(s) shall be converted into OM as provided under Section 09 (2) of J&K Reservation Act, 2004 and shall be allotted to the candidates on the basis of merit cum preferences.

Note -I:

The following procedure shall be followed during the 2nd/Mop Up Upgradation/Allotment Round of Physical Counselling.

- i) The eligible candidates have to report at the BOPEE offices Jammu / Srinagar for Registration/Attendance & fulfillment of other formalities, from **08.30 a.m. to 10.00 a.m.** on the day/date of counselling.
- ii) The above mentioned reserved category candidates shall have to bring along their reserved category certificate(s) and the CDP category candidates are advised to bring along their valid Priority Certificates for check and verification at the time of counselling.
- iii) Those candidate(s) who have been allotted seat(s) during the 1st Round of Counseling and have joined against the said Seat / College, if interested, for upgradation are eligible to participate in the 2nd/Mop Up Round of Physical Counselling with the condition that he/she shall have to produce his/her fee deposition receipt of the concerned allotted College at the time of Registration/Attendance on day/date of counselling.
- iv) The eligible candidates who have failed to participate in the First Round of counselling due to one or the other reason shall also be eligible to participate in the counselling.
- v) Due to time constraints, the Board shall club 2nd & Mop up rounds of counselling as one time exemption for these courses and for current session only, hence accordingly, the candidate(s) who have been allotted Seat(s) during the First Round of counselling, but have failed to join, they shall also be eligible to participate in the 2nd/Mop Up Round of counselling irrespective of eligibility mentioned in the Notifications/Notices issued by the Board from time to time in this regard.
- vi) The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control.

Note -II:

The Seat Matrix for 2nd/Mop Up Round of counselling shall be uploaded on website of the Board before the day/date of counselling for information of the candidates.

The counselling shall automatically stop as and when the seats get exhausted and no claim(s) from the waiting candidates, if any, shall be entertained by the Board.

The candidate(s), if any, is not able to participate personally in the counselling on designated date of counselling due to unavoidable circumstances he/she can authorize his/her close family member who falls in his/her blood relation on the devised format of the Board to participate in the counselling on behalf of the concerned candidate.
