Subject : Merit list and Select List regarding engagement of Sanginis (AWWs).

Whereas vide this Office Advertisement Notice No. 01 of 2023 dated: 13-05-2023 applications forms from eligible female candidates were invited against 37 vacant posts of Sanginis (AWWs) of Project Kathua. Whereas 02 posts of Sanginis at AWC Palyani and AWC Bignawa have been kept withheld due to typographical error in location of Ward No. of the said Anganwadi Centres.

Whereas 292 candidates have applied against remaining 35 available advertised vacant posts of Sanginis (AWWs) in project Kathua.

Whereas the merit and other necessary particulars of all the candidates were scrutinized/checked on 31.07.2023 by the committee constituted vide Govt Order No.- 103 -JK(SWD) of 2023 dated:- 28-04-2023 and Govt Order No. 222 -JK(SWD) of 2022 dated: 30-11-2022.

Whereas vide this Office Notice No. 02 of 2023 dated 31.07.2023, the provisional /tentative merit list and provisional /tentative select list regarding engagement of Sanginis have been published in State Times dated 10.08.2023.

Whereas the copy of the provisional/tentative merit list and provisional /tentative select list was provided to all the Sanginis/Parcs concerned and also posted at other locations as per aforementioned Govt. Orders.

Whereas the Provisional/tentative Merit List and Provisional/tentative Select List were issued with necessary riders/observations put against the candidatures of 120 candidates by the Selection Committee.

Whereas after the expiry of 10 days from the date of publication of this notification No. 02 of 2023 dated 31.07.2023 in State Times dated 10.08.2023, the riders/observations of 09 candidates were omitted/excluded in Provisional/tentative Merit List and Provisional/tentative Select List by the Selection Committee after receiving necessary/requisite documents/ re- verification of ward residence proofs from applicant ACR.

Whereas after the expiry of 10 days from the date of publication of this Notification No. 02 of 2023 dated 31.07.2023 in State Times dated 10.08.2023, 08 grievance/objecton has been received by the CDPO Kathua (Member-Secretary Selection Committee for Sanginis) within the prescribed time limit which is disposed off by the Selection Committee.Orders.

Whereas the selection list was approved by Additional District Development Commissioner Kathua vide letter No. ADDCK/8/2023-24/2725-28 dated 20/11/2023.

Therefore in view of the above and as per the procedure laid in the above referred Govt Orders, the Merit list and the Select list as Annexure-A and Annexure-B respectively are hereby published for the information of general public and all concerned.

Grievance(s)/Objecton(s)if any), the appeal in this regard shall lie before Deputy Commissioner Kathua within 10 days from the date of publication of this notification/list. No grievance(s)/Objecton(s) of any kind shall be entertained after ten days from the date of issuance of this notification/list.
