Shah slammed Harvana Congress leader Bhupinder Hooda, saying, "I want to ask Hooda ji whether the development which took place in the last nine years (under BJP) is visible or if (your) eyes are still shut."

Terming the INDIA coalition a "ghamandiya" (arrogant) alliance, Shah alleged that all the 27 constituents of the opposition bloc are "parivarvadis" (dynasts).

"All the 27 outfits are 'parivarvadis'. Some have to adjust their son, some have to make their son prime minister, some have to save their son from agencies while some have to make their son chief minister. Some have to become Madam's loyalists. Can these parties do any good for the people?" Shah asked.

He also targeted the Congress over the Ram Temple issue.

For decades after Independence, the Congress kept the Ram Temple issue hangng and hindered its construction in Ayodhya, he alleged

"Should the Ram Temple have been built in Ayodhya on time or not," he asked the gathering:

Shah said it was Prime Minister Narendra Modi who laid the foundation of the

temple At the event here, Shah, in presence of Chief Minister Khattar and others, launched five schemes for the 'Antyodaya' families.

Several Haryana ministers, Union minister Rao Inderjit Singh, and state BJP chief Nayab Singh Saini were among those present at the event in Karnal, which is also CM's home constituency. However, no one from BJP's ally JJP was present. Shah said the government has been carrying forward the 'Antyodaya' welfare polcy based on Pandit Deen Daval Upadhyaya's vision.

'Antyodaya' means the welfare of the people in the bottom of the pyramid. Shah also attacked the previous governments headed by Congress' Hooda and INLD's O P Chautala

"What you (Hooda) had done? You gave the rule of fear, corruption and hunger," Shah said.

"When Hooda came, there was massive corruption. There was an auction of Haryana land to serve 'damad' (referring to Sonia Gandhi's son-in-law Robert

Vadra)," he alleged. When Chautala came, the law and order situation turned bad, he said.

Both of them had indulged in corruption in government recruitments during their respective regimes, he alleged. However, the BJP government in Haryana gave jobs to people on merit and with-

out any money, he said. Shah also accused Hooda and Chautala of indulging in developing their own dis-

But the BJP government carried out development across the state, he added. Sharpening his attack on Hooda, Shah said from "darbaris" (courtiers), "damad' and "dealers" government, the BJP regime has made Haryana a developed state. Attacking the Congress, he said during the Congress-led UPA regime, there used to be attacks from Pakistan every day.

"'Aaliya maliya jamaliya' (referring to infiltrators) from Pakistan used to carry out oomb blasts on a frequent basis," he said.

During Modi's rule, Pakistan committed mistakes in Uri and Pulwama, he said. "But they forgot that it was not the Congress government, it was the BJP governnent. It was not 'Mauni Baba' Manmohan Singh, but Narendra Modi who is the

"Within 10 days, surgical and air strikes were carried out in Pakistan to teach a

Shah also inaugurated new schemes initiated by the Haryana government for Antvodava' families' upliftment.

The schemes launched by Shah included the 'Mukhyamantri Tirth Yatra' scheme. According to officials, under this scheme, members of families with an annual ncome of less than Rs 1.80 lakh who are over 60 years of age will be taken for pilgrimages to Ayodhya, Varanasi, and other sacred places.

The state government will bear all the expenses for their travel.

Shah also listed various initiatives and schemes of the Narendra Modi government

Asking people to vote for the BJP in the next general elections and make Narendra Modi the country's Prime Minister again, Shah attacked the Congress, saying it can neither develop Haryana nor the country.

Both Modi and Khattar governments have left no stone unturned to take the country and state ahead, he said.

Under Modi's leadership, seven IITs, seven IIMs, 15 AIIMS, 390 universities, 700 nedical colleges and 54,000 km national highways were built, said Shah.

The Union home minister said in Haryana, the Khattar government built 77 new colleges, 13 universities, eight medical colleges, two new airports, 16 new hospitals and 28,000 km road length was built.

sowing 1.75 Cr saplings besides carrying out demarcation of the boundaries of all the vulnerable forest areas.

The meeting was attended by Principal Secretary, Forests; Principal Secretary, Finance; PCCF, HoFF; Chief Wildlife Warden; PCCF (CEO), CAMPA; DG, Planning; Addl CCFs besides other concerned officers of the Department.

Outstation based officers participated in the meeting through video conferencing. During this meeting the Chief Secretary enjoined upon the officers to attain all the deliverables set for the department on time. He stressed on achieving the target of sowing 1.75 Cr saplings and distribution of 90 lakh seed balls as envisaged under the annual plan of the department.

Dr Mehta also impressed upon the officers to focus on revitalization of the degraded forest areas and ensure that the dense and moderate forest cover of the UT increases with time. He maintained that the peculiarity of this region is its unique ecology and environment, which distinguishes it from other States/UTs. He made out that the Department has the responsibility to maintain it sustainably.

The Chief Secretary impressed upon the officers of the Department to complete the process of demarcation and geo-referencing of all the forest areas forthwith before the onset of winters. He called for setting up of new benchmarks in management of National Parks, Wildlife Sanctuaries, Wetlands and notified areas. He asked for complete digitization of official records and fixing of their boundaries to evade any chances of trespassing.

Dr Mehta called for making all the forest areas plastic-free. He observed that forests are the best places to de-stress the minds and the department should encourage people to visit these natural habitats and promote eco-tourism. He advised installation of proper signages and other bill boards containing information in a manner so that people are informed about the utility and significance of such treas-

On the occasion Dr Mehta also released a document capturing the restoration plan for Gharana Wetland of Suchetgarh, Jammu. He took note of all the measures taken for restoration of other water bodies like Wular, Mansar, Surinsar and Shalabugh. He advised that the restoration measures for protection of these water bodies should be gauged separately as the Department has both the expertise and resources to do the same.

He also recalled the measures taken a year back to make Palli Panchayat of District Samba a carbon-neutral village. He maintained that in order to achieve the target of net-zero carbon emissions by 2047 as aspired by the Prime Minister it is essential to have Panchayat level carbon neutral plans to make this happen within the deadline

On the occasion the Principal Secretary, Forest, Dheeraj Gupta informed the meeting that the Department is going to complete the demarcation of the vulnerable forest areas by 15th of December this year. He also said that process of digitisation and geo-referencing of all the forest areas will be achieved by the end of the

The CEO, CAMPA in his presentation gave out that the Department had an original APO outlay of Rs 272 Cr for 2023-24. He further elucidated that in order to achieve the milestones of planting 1.75 Cr saplings, installation of nearly 1,16,266 boundary pillars and digitization and geo-referencing of forest lands it has become imperative to ask for the additional APO to the tune of Rs 53.44 Cr. This is in addition to the amount invested through ploughing back of savings made on tendering and other interest amounts of the department taking the total additional requirement to Rs 81.24 Cr for the financial year.

It was further apprised that department saved an amount of Rs 16.28 Cr through e-tendering of its works. The additional works envisaged under the funding includes installation of additional 89,569 BPs, 8.5 lakh plants and digitization and demarcation of forest boundary lines and works related to protected areas in the UT.

Rafiq Pahloo appeared before a special court here on Thursday via video conference in connection with the 1989 abduction of Rubaiva Sayeed, the daughter of the then Union home minister Mufti Mohammad Sayeed.

Two evewitnesses examined in the court identified Ali Mohammad Mir as another accused in the case, Senior Additional Advocate General and Chief Prosecutor of the

CBI Monika Kohli told PTI. She said the next date of the hearing was fixed on December 14.

"In the 1989 Rubaiya Sayeed abduction case, two witnesses were examined.

Giving further details, senior public prosecutor S K Bhat told PTI that two witnesses numbers 24 and 25 were examined. They supported the prosecution and identified accused Ali Mohammad Mir, he said. Ali Mohammad Mir, who is

the prime accused in the kidnapping case after Malik, had taken Rubaiya Sayeed in his vehicle to Sopore from Srinagar and kept her at a guesthouse.

It was also revealed that permission/affiliation granted by the Directorate to the Institute Kissan Technology, R.S. Pura, Jammu an Industrial Training Institute (ITI) for running the courses under NCVT and SCVT was also kept in abeyance till further orders and the institute was not allowed to make any admissions in any of the trades from August, 2016. However, the institute in violation of the norms and the standing orders and in furtherance of a criminal conspiracy admitted the students and issued them fake diploma certificates, which were used by these candidates in order to secure Govt. job through fraudulent means.

On receipt of the complaint along with the verification report instant case was registered by Crime Branch

Jammu under the relevant sections of law for indepth investigation. During the material evidence in the form of documentary record, FSL report was collected from concerned quarters besides statements of complainant/witnesses u/s 161 Cr.PC was recorded and also keeping in view the circumstantial evidence enumerated above, it has been found that the accused cheated the students by providing them fake Plumber/Electrician diploma certificates /diplomas for NCVT trade and SCVT trades, knowingly that they were not authorized to conduct such exams and issue such diplomas. Offences 420,465,468,471,120-B RPC has been proved against accused persons.

In the meantime EOW-CB Jammu also produced charge-sheet in another case FIR No. 68/2022 U/S 420, 465, 468, 471/RPC P/S Crime Branch Jammu for judicial determination.
