Pursuant to Notification No. 104-BOPEE of 2023 dated 27.10.2023, the Board has conducted 2nd Round of Physical counselling for filling up of seats of Ayush Courses -2023 which had remained unfilled or received as shortfall after the conduct of first round of counselling on 30th & 31st of October 2023 at BOPEE office Srinagar/Jammu simultaneously. The provisionally selected candidates shall have to mandatorily report for admission to the allotted Colleges / Institutions by or before 06.11.2023 upto 4:00 p.m. along with their relevant certificates/documents in original, failing which they shall not be eligible for further round of counselling, if any, conducted by the Board.

The concerned Colleges/Institutions shall furnish the shortfall, if any, on 06.11.2023 upto 05:00 p.m. positively to enable the Board to take further appropriate action in the matter.

Note:

1. The admission of candidates shall be purely provisional and liable to be cancelled in case any information furnished by any candidate(s) proves to be false / fabricated and action as warranted under law shall be initiated against them.
2. If any candidate(s) is found to have concealed any information, his/her selection/admission shall be cancelled ab-initio and fine/penalty shall also be imposed upon him/her as may be deemed proper by the Board in accordance with the laid down rules.
3. All the provisionally selected candidates are advised to visit their respective allotted Colleges/Institutions for fee and other relevant documents required by the respective Colleges/Institutions.
4. It is the sole responsibility of the concerned Colleges/Institutions to check and verify the documents and eligibility of the provisionally selected candidates before allowing them to join in their respective Colleges/Institutions.
5.
