- Whereas, the festival of Diwali is falling on 12th Nov 2023 and it is anticipated that crackers may be extensively used by the people for celebrations and the stalls will be put up for storage and sale of crackers and other explosive materials; and
- 2. Whereas, indiscriminate storage and sale of crackers and other explosive materials is likely to cause inconvenience to the public, besides, posing risk to private life and property; and
- Whereas it is considered expedient and necessary to regulate the storage and sale of crackers and explosive material in the public interest; and
- 4. Now, therefore in exercise of the powers vested in me under Section 144 Cr.Pc, I, Dr. Rakesh Minhas, IAS, District Magistrate, Kathua hereby Order that:
 - a) No fireworks, crackers or explosive material shall be stored or sold in place other than those specified by this office for the areas within Kathua Municipal Limits, and by the respective ADM's/ SDM's/ Tehsildars for the areas outside the above in Kathua District.
 - Stalls for sale of fireworks, crackers etc shall be put by concerned dealers only at places mentioned in their permissions after getting clearance from the Fire Services Department Kathua, Police, Municipal Council/Committees and Revenue authorities

The Maximum amount of explosives which may be kept at any particular time at

Licenses premises shall not exceed the quantity given in class 7 Div. 2, Sub Div,

- II, of the explosive rules SCIV. d) Electrical fitting in the premises shall be affixed properly, without any loose wires. Also one CFL tube shall be installed in the close vicinity of the stock of the
- explosives for proper illumination of the area. e) No person under 18 years of age or who is in the state of intoxication or of unsound mind shall be employed for loading/unloading of transportation of explosives or be allowed to enter in the licensed premises.
- No explosives which are not authorized under rules or prohibited under Section
- 6(A) of Act Shall be possessed or sold from the premises. Chocolate Bomb, Chain Cracker, (Kali Pataka, Loose Cracker) Dhani Pataka, Dodoma, Seven Shots, Rocket Bomb, Garlant Patakas, Stat Bomb etc, shall not be allowed to be sold by any wholesale cracker dealers/retail cracker dealers in
- the district to curb noise pollution. h) Imported fireworks containing sensitive chemical substances which are not permitted under Indian Statute and also do not comply with the Indian Noise
- Level Standards shall not be sold by wholesale cracker dealer/Retailer.

 No retail sale of crackers or other fireworks shall be undertaken by any
- authorized person at his shop/premises after the Diwali Festival. Crackers and other explosive material shall contain a price tag which shall not be more than the price printed on each explosive. The price printed shall be deemed to include all local taxes even if the printed specifically reads "Local Tax Extra".
- k) In case any wholesale or retailer contravenes any of the conditions specified above, not only the permission granted in his favour shall be cancelled and his stock seized but shall be liable for prosecution under relevant provision of Law.
- Only green crackers are allowed to be sold as per advisory issued by competent
- This order shall come into force with immediate effect and shall remain in force for till 30-11-2023.
