He was a spiritual person who meditated regularly from 2.30 AM onwards and continued till last. He breathed his last on 28th October, 2023 after a brief ailment. 

Court discharges five accused involved in terror attacks

JAMMU: Ist Additional Sessions Judge Srinagar discharged five alleged militants who were involved in 2003 militant attack case at the stage of framing charges.

Those who are discharged are Showkat Ahmad Wani, Riyaz Ahmad Shah, Fayaz Ahmad Bilal, Sami-ullah Khan and Mohammad Altaf Mir.

The brief facts of prosecution case are that on 6 January 2003 the Police station Shergari has received an information from reliable sources that a group of militants armed with illegal automatic weapon has opened fire on one Abdul Hamid Sheikh son of Abdul Khaliq of Allochi Bagh Srinagar; at Solina near petrol pump with the intention to assassinate the victim. On the receipt of the information the case FIR No. 4/2003 under Section 307 RPC read with Section 7/27 Arms Act came to be registered in the Police Station Shergari. A team of officers from the police station rushed to the place of occurrence and shifted the injured to the hospital where he was declared brought dead. The case initially registered under Section 307 RPC was converted into one under Section 302 RPC and the investigation taken over by SHO of the police station. The investigating officer recorded the statements of the witnesses, got post-mortem of the dead body conducted and handed over the body to the

family of the deceased. The investigation revealed that the deceased was running liquor business at Allocha Bagh Srinagar; and respondent no. 6, a well-known militant of Tenggpora Batamallo, was extending threats to the victim to force him to close his liquor business and when the deceased unmindful of the threats continued with the business, accused no. 6 opened fire on him with the intention to kill him. The investigation also revealed that at the time of occurrence respondent no. 6 was seen running with associates carrying a pistol in his hand. While the investigation was on, a news item appeared in 7th January, 2003 issue of a local daily saying that militant outfit Hizbul Mujahideen has claimed responsibility for killing Abdul Hamid Sheikh. The investigation further revealed that accused no. 6, District Commander of Militant outfit Hizbul Mujahideen for Srinagar and Budgam districts, organised a group of militants comprising accused 1 to 5 to carry out the attacks like one in question. The investigating officer due to non-availability of sufficient evidence and failure to arrest the accused stopped the investigation but continued with the secret inquiry. The investigation was revived and threads picked up from the stage the investigation was stopped, in wake of order No. SPS/ Shergari/ 6407 dated 19th November, 2005. The
