Asked about the use of drones by Pakistan to smuggle weapons and narcotics, he

"You stay relaxed and be assured that all measures are in place. Government has nade available all resources and a close watch will be kept so that there is no infiltration," he said.

in Jammu, police initiated a search operation on Tuesday, the official said. They intercepted Mukhtiyar with his motorcycle near the hospital mortuary and recovered the heroin-like substance and Rs 9,000 in cash from him, he added.

A case has been registered against him at Bakshi Nagar Police Station and he has been suspended from service.

The official stated that Mukhtiyar is believed to be part of a drug syndicate active in Jammu, responsible for selling drugs to innocent youth for illicit profit. This syndicate is suspected of being involved in drug overdose deaths in the area.

"SP City North, Brijesh Sharma, is personally supervising the investigation to uncover the connections of these drug peddlers and dismantle the entire drug ecosystem established by this syndicate," he said.

"Their financial investigation is also ongoing to identify properties acquired through narcotics proceeds, to attach these illegitimate assets," he added

In a similar incident on November 7, constable Parwaiz Khan was arrested along with his two wives during a raid on their house. Heroin and more than Rs 2.5 lakh in cash were seized from them.

their hands, should be made accountable for such high-handed actions," the bench

The top court said when it is considering the issue with regard to 'rule of law' and 'separation of powers', it will also have to take into effect the matters where the Executive transgresses its power, acts as a judge and demolishes the structures of persons without following the procedure prescribed by law.

"Though the doctrine of public trust has been largely applied by this court in environmental matters, it cannot be disputed that the executive exercises its powers as a 'trustee' of the citizens. Therefore, the executive actions must be consistent with maintaining public trust." it said.

The bench said conversely, when the Executive acts in breach of the principles of 'rule of law' and 'separation of powers', the doctrine of public trust and accountability would come into play. It noted that even in cases consisting of imposition of a death sentence, it is always

a discretion available to the courts as to whether to award such an extreme punish-It said there is even an institutional safeguard in the cases of such punishment to

the effect that the trial court's decision imposing death penalty cannot be executed it is confirmed by the high court.

The bench said even in the cases of convicts for the commission of most extreme and heinous offences, the punishment cannot be imposed without following the mandatory requirements under the statute. "In that light, can it be said that a person who is only accused of committing some

crime or even convicted can be inflicted the punishment of demolition of his property/properties? The answer is an emphatic 'No'," it said.

The top court said the principle that "an accused is not guilty unless proven so in a court of law" is foundational to any legal system.

It said this principle ensures that individuals are not unfairly punished or stigmatised based solely on accusations or suspicions.

The bench said the right to a fair trial is essential in upholding the rule of law and protecting individual liberties and it ensures that principles of natural justice and fair process are being strictly followed.

"It is thus required that the trial must be fair and open, but not prejudiced by public clamour. The precepts of natural justice are to ensure that the legal order will be impartially and regularly maintained," it said.

The top court delivered its verdict on pleas seeking framing of guidelines on demolition of properties in the country.

### Girl dies after being hit by boulder during road construction in Poonch

MENDHAR/JAMMU: A seven-year-old girl died after being hit by a boulder during construction of a link road in Jammu and Kashmir's Pooneh district on Wednesday, officials said.

Zahara Choudhary was returning home from her school in Salwah village when the incident took place during construction of a link road, the officials

They said the minor girl was hit by a boulder which was being removed by an earth-mover.

"The girl had suffered a major injury in the lumbar and pelvic area and died of internal bleeding," Block Medical Officer, sub-division hospital Mendhar, Dr Ashfaq Choudhary told PTI. He said the girl was brought dead to the hospital and later her body was

handed over to police after completion of autopsy. The angry villagers demanded action against the construction company for

alleged negligence. Police have taken cognizance of the incident and further investigation is on, the officials said. Meanwhile, the body of a 38-year-old man was found in his

village at Check Balole in Poonch district on Wednesday, the officials said. They said the post-mortem was conducted at the Sub-district hospital Mendhar and later the body was handed over to his relatives for last rites. Police have started inquest proceedings to ascertain the cause of his death, the officials said

## Govt to ensure seamless, timely transfer of Toshkhana assets

JAMMU: The Hospitality and Protocol Department has strongly countered and corrected several misinterpretations regarding the transfer of Toshkhana assets saying efforts are being undertaken by the Department, alongside other governmen tal bodies, to ensure a seamless and timely transfer of these invaluable assets.

According to a communication issued here, the claim of "inordinate delay and lack of coordination" fails to consider the intricate and multi-layered nature of the process. It reads 'Toshkhana assets include historically significant artifacts, pre cious metals and antiques of immense cultural value. The inventory and handover of such items require careful, exacting documentation, as well as collaboration across multiple agencies.

Due to the historical and irreplaceable nature of these items, it is essential to account for each piece precisely and securely. Moreover, certain items are housed in locations protected by multiple security layers, making access to them logistically challenging and understandably time-intensive". "The Hospitality and Protocol Department initaited immediate action following

the Administrative Council's decision on August 13, 2022, as formalized by Government Order No.11-JK(H&P) on August 30.2022, which sanctioned the clo sure of Toshkhana Organization. In line with this directive, the department prompt ly initiated measures for asset transfer, issuing necessary instructions to relevant departments. However, the preservation and management of the assets require a collaborative and structured approach. Recognizing this, the government of J&K proactively constituted specialized committees under General Administration Department Order No.992-JK(GAD) dated August 21, 2023", read the document These committees are being led by the Deputy Commissioners of Jammu and Srinagar and comprise of experienced, high-ranking officials including the Senior Superintendents of Police, Director Hospitality and Protocol Department and the Director of Archives, Archaeology and Museums. The committees have a critical role in coordinating across departments, ensuring that each piece within the Toshkhana is carefully cataloged and systematically transferred according to established protocols.

The communication further read "The Deputy Commissioners in both Jammu and Srinagar are at the helm of these efforts and are fully conscious of the urgency of this issue and have adopted a proactive approach. Under their guidance every efforts being made to expedite the transfer while prioritizing the security and preser vation of the Toshkhana items. The committees are implementing streamlined pro tocols and addressing any procedural delays as they arise. They remain steadfast in coordinating across different administrative branches, ensuring all elements of the inventorying and transfer process are managed with the utmost efficiency and adherence to legal and procedural norms".

The committees are working on a collaborative, "All-of-government" approach, rec ognizing the importance of each department's role in achieving a common objective This approach underscores the government's dedication towards preserving these assets and managing the transfer with precision.

The process is progressing as efficiently as possible given the logistical challenges procedural safeguards, and preservation standards necessary for transferring such valuable items. Far from neglecting their responsibility, the involved departments and committee members have been working tirelessly to meet the intricate require ments of this undertaking.

"The government is fully committed towards completing this transfer responsibly and expeditiously. We urge recognition of the complexity of this task and of the ded icated, ongoing efforts by the committees led by the Deputy Commissioners of Jammu and Srinagar, who are managing this process with diligence care, and accountability", read the official communication.
