Application forms are invited from interested persons belongs to Schedule Tribe community having ST category certificate for the establishment of mini sheep/goats farms comprising of 10 ewes/Does under the Tribal Sub Plan (TSP) Retrieval for the year 2024-25 with prescribed terms and conditions. Sheep units comprising of 10 Ewes/Does shall be provided to the beneficiaries free of cost and from 3rd year of establishment, the department shall retrieve 2 Ewes/Does per year from each beneficiary for the next five years. The progeny to be retrieved should be 1.5-2 years of age with minimum body weight of 25-30 kg.

Terms and Conditions:

- Selection of beneficiary will be done by committee constituted for the purpose through "Draw of Lots" procedure.
- The beneficiary shall be provided a unit after executing an agreement (as per prescribed format) to the effect that the beneficiary will return 2 ewes/does per year out of progeny to the Department from 3rd year for the next five years.
- The retrieved animals shall be used for the establishment of units.
- The beneficiary shall furnish an affidavit duly attested by 1st class Magistrate as per the prescribed format.
- The beneficiary shall insure the animals from the date of establishment of unit till full retrieval is made by the department.
- Unemployed youth shall be given preference.
- The beneficiary/household who has already availed the benefits under any income generating scheme of Sheep/any other department shall not be eligible.
- More than one application form from the same household shall not be entertained.
- The selected applicants must obtain a techno-feasibility report from the concerned VAS.

Eligibility:

- Any individual/group of individuals/self help groups/cooperative society/farmer producer organizations (Efforts shall be made to cover 10% women beneficiaries)
- Applicant must have sufficient land holdings, infrastructure, fodder/grazing provisions and manpower resources to maintain the unit on organized pattern.
- Minimum age limit for beneficiaries shall be 18 years and a maximum age limit of 55 years.
