05) QUALIFICATION REQUIRED:

- a) As per the Indent received from the Indenting Department and relevant recruitment rules, the qualification prescribed for the advertised posts is shown in Annexure-A to this Notification.
- b) The candidates who are declared qualified by the Board for Document Verification will be required to produce relevant Certificates in original as proof of having acquired the prescribed educational qualification on or before the cut-off date fixed for filling online application forms, failing which the candidature of such candidates shall be cancelled by the Board. c) Candidates may note that their candidature/admission in examination will remain

07) HORIZONTAL RESERVATION (wherever applicable under rules):

- f) In case sufficient number of candidates belonging to the Ex-servicemen are not available on the basis of General standard to fill all the vacancies reserved for them, candidates belonging to the category of Ex-servicemen may be selected under the relaxed standard of selection to make up the deficiency in the reserved quota subject to the condition that such relaxation will not affect the level of performance by such candidates.

10) SCHEME OF EXAMINATION:

(I) WRITTEN EXAMINATION:

- a) The Examination will consist of Objective Type Multiple Choice Questions. The questions will be set in English Language only.
- b) There will be Negative Marking for each wrong answer to the extent of one-fourth ofmarks assigned to that guest
- c) In terms of SO 290 dated 20.08.2021 of Home Department, the randidates possessing National Cadet Corps (NCC) Certificate shall be awarded bonus marks, at the following scales
- () 5% of the maximum marks of the examination for NCC "C" Certificate holders. ii) 3% of the maximum marks of the examination for NCC "B" Certificate holders. III) 2% of the maximum marks of the examination for NCC "A" Certificate holders
- (II) PHYSICAL STANDARDTEST: The candidates shall be shortlisted for appearing in the physical standard test on the basis of written test which shall be six times the total number of vacancies to be filled up in each category. The shortlisted candidates should meet the following physical standards:

a) For Males:

- i) Height: 5'-6" (minimum)

Explanation 1: For the purpose of this rule, the age of the Ex-Serviceman shall be his actual age i.e.as on 1º January of 2024.

Explanation II: All Ex-Servicemen shall be required to pass the written tests and fulfill the prescribed physical standards apart from meeting the medical standards prescribed for direct recruits.

Note: The Physical Standard Test and Physical Endurance Test shall be of qualifying nature only.

C) Medical Examination

The selected candidates, with reference to the vacancies, will be medically examined to assess their physical and medical fitness.

11) SYLLABI FOR THE POSTS:

The Syllabus for the posts shall be notifiedseparately and made available on the official website of JKSSB

12) ADMISSION TO THE EXAMINATION:

- a) The Board will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of written examination and, therefore, candidature will be accepted only provisionally. The candidates are instructed to go through the requirements of educational qualification, age, and reserved categoryparticularly w.r.t. "cut off date" and satisfy themselves that they are eligible for the post. Copies of supporting documents will be sought at the time of Document Verification. When scrutiny is undertaken, if any claim made in the application is not found substantiated or correct, the candidature will be cancelled, and Criminal Proceedings under law may also be initiated, or any other action as may be deemed appropriate by the Board, shall be taken.

18) PROCEDURE FOR FILLING ONLINE APPLICATION:

The necessary instructions regarding filling up of online applications, including the details of Online Portal in this regard shall be made available on the Board's Website separately. Candidates will be required to fill the application form in online mode only and no other means/mode of application will be accepted.

19) IN-SERVICE CANDIDATES:

In service candidates shall submit print out of filled online application form along-with duly filled, signed and stamped Certificate given at last paragraph of the application form through proper channel viz. the concerned Head of Department (as defined in the JK Book of Financial Powers).
