WHEREAS, it was reported by Dy. Controller Legal Metrology (Enforcement) Jammu vide his office communication No. LM/DC/Enf/78/2024-25 dated 08.05.2024, that Mr. Sahil Sharma, Multitasking Staff (MTS) submitted an application for sanction of 3 days casual leave w.e.f. 09.11.2023 to 11.11.2023 on the ground of not feeling well due to viral fever;

WHEREAS, Mr. Sahil Sharma, Multitasking Staff (MTS), in the office of Dy Controller, Legal Metrology (Enforcement), Jammu (DDO), did not report back and remained un-authorisedly absent from the Government duties and accordingly he was directed by his DDO to resume back his duties vide office communication No. LM/ DC-Enf. / 542/ 2023 dated 25.11.2023;

WHEREAS, Mr. Sahil Sharma, Multitasking Staff (MTS), Legal Metrology neither responded to the above said notice nor reported back to his duties and accordingly 2nd notice to join back the Government duties was given to him by his DDO vide his office communication No. LM /DC/ Enf/ 693-695/ 2023-24 dated 23.02.2024;

WHEREAS, despite above said notices, Mr. Sahil Sharma, Multitasking Staff (MTS), did not respond to the above said notices and accordingly a final notice/ last opportunity in the interest of principle of natural justice was offered by the concerned DDO vide his office communication No. LM /DC/ Enf. /13-15 / 2022-23 dated 19.04.2024 and the said notice was also served through the medium of print media by publishing the same in leading newspapers.

WHEREAS, Rule 8(i) of J&K Civil Services Leave Rules, 1979 reads as under:-"Leave cannot be claimed as a matter of right".

WHEREAS, Rule 25(2) of J&K Civil Services Leave Rules, 1979 reads as under:-

"Willful absence from duty after the expiry of leave renders a Government Servant liable to disciplinary action"

WHEREAS, Article 128 of J&K Civil Services Regulations, 1956, Volume-I envisages as under:

"Absence without leave or after the end of leave involves loss of appointment.....

WHEREAS, despite giving sufficient opportunities, Mr. Sahil Sharma, Multitasking Staff (MTS), neither reported nor responded to any of the communications/ notices as intimated by his DDO vide his office communication No. LM/DC/ Enf./78/ 2024-25 dated 08.05.2024;

WHEREAS, in past also, he remained unauthorizedly absent from Government duties and even visited outside country without permission from the competent

authorities and accordingly his unauthorised absence from duties was decided as "Dies-Non" in term of Article 163 of J&K, CSR vide this office Order no. 18-LM of 2023 dated 19.09.2023 besides stopping two annual increments as penalty with a warning for remaining careful in future. The operative portion of said Order dated 19.09.2023 is reproduce as under:-

- "LThe period of un-authorized absence of Mr. Sahil Sharma MTS LMD w.e.f. 15.07.2022 to 10.04.2023 shall be treated as 'Dies-Non' in term of Article 163 of J&K, CSR.

 It Two sets of annual increments becoming due in future shall be deemed withheld" as penalty in term of rule 30(ii) of the Jamuu and Kashmir Civil Service (Classification Control and appeal rule, 1956 with a further warning to remain careful in future and to do nothing which is unbecoming of

WHEREAS, un-authorised absence from Government duties by Mr. Sahil Sharma, Multitasking Staff (MTS), clearly indicates that he is not interested to serve this department, as such the concerned DDO recommended the termination of his services after giving him sufficient opportunity of being heard in accordance with principle of nature justice;

WHEREAS, in view of the recommendations of Deputy Controller Legal Metrology Department (Enforcement), Jammu (concerned DDO), a pre-termination notice in the interest of principle of natural justice was served upon Mr. Sahil Sharma, Multitasking Staff (MTS) at his residential address by this office vide communication No.LM/C-Estt/01/200323/2022 dated 27.05.2024 apart from publishing the same in print media directing him to join his duties within a period of one week if he is interested to serve the department, however, Mr. Sahil Sharma, MTS, Legal Metrology Department, neither resumed his duties nor responded to the above said pretermination notice despite lapse of substantial time;

WHEREAS, the above case of un-authorised absence examined in the department in terms of the rules/regulations governing the subject and his failure to reply/ respond to the notices issued to him from time to time is voluntary act and clear indictive of 'not interested in the Government service' and hence liable to be dismissed/ terminated/discharge from the Government service: And

Now, therefore, in terms of Article 128 Volume-I of the Jammu and Kashmir Civil Service Regulation, 1956, Mr. Sahil Sharma, MTS, Legal Metrology Department, is hereby terminated and discharged from the Government service with effect from 12.11.2023.
