A. The number of seats/disciplines for MD/MS course as available in ASCOMS-Jammu under Hindu Minority / NRI Quota:

1. Hindu Minority Quota Seats - 13
2. NRI Seats - 05

B. The NRI / Hindu Minority Quota seats for MD/MS in ASCOMS shall be filled up separately through a process of Physical/Online counselling, the schedule for which shall be notified separately by the Board.

Important Note:

- The last date for submission of the documents under NRI/Hindu Minority Quota physically at BOPEE office Jammu/Srinagar is: 02-12-2024 (till 03:00 P.M.).
- The check list Proformas for Hindu Minority (HM) / NRI is available as **Annexure-A & B** to this Notification only on the official website of BOPEE i.e. www.jkbopee.gov.in only.

General Conditions: - The candidates applying for NRI/HM Quota seats;

- should have applied under NEET PG-2024 and have qualified /obtained minimum qualifying percentile score as an eligibility condition and
- should also have uploaded other documents except HM/NRI certifications during registration process on BOPEE website in response to the Notification No. 121-BOPEE of 2024 dated 27- 09- 2024.

Fee Structure: -

The fee is fixed by the Government of J&K for MD/MS seats in ASCOMS vide Government Order No. 659-HME of 2019 dated 10-07-2019 read with Government order no. 221-HME of 2016 dated 01-04-2016, & eligible candidates are advised to confirm fee from respective College before submitting the documents at BOPEE office Jammu/Srinagar.
