JAMMU: In a significant development, the Anti-Narcotics Task Force (ANTF) Jammu has booked a notorious drug peddler, Harjeet Singh, son of Jhanda Singh, resident of Abtal Ramgarh, District Samba, under the Prevention of Illicit Trafficking in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act. Harjeet Singh had been evading arrest for several months and was a long-standing target of the

authorities. The operation was led by Inspector Amandeep Singh of the ANTF team, under the direction of DySP Tanweer Gilani, and the overall supervision of Rai Kumar, SSP ANTF Jammu and Kashmir. The execution of the long-pending warrant was carried out today with the cooperation of District Police Samba.

The Divisional Commissioner Jammu had issued a warrant under the PITNDPS Act (Order No. 18 of 2024, dated 14-02-2024) against Harieet Singh, who is a habitual drug peddler involved in two separate cases under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.
