UG students to...

has approved the SOPs for HEIs to offer the Accelerated Degree Programme (ADP) and Extended Degree Programme (EDP) in a meeting this week. The draft norms will now be out in the public domain for feedback from stakeholders.

While the degrees will mention a self-contained note that the academic requirements needed in a standard duration have been completed in a shortened or extended duration, they will be treated at par with standard duration degrees for academic and recruitment

Top foreign universities also offer the option to students to finish their degree earlier or ater than stipulated duration. "Students can use this option to shorten or extend their study durations based on their learning abilities. ADP allows students to complete a threeyear or four-year degree in reduced time by earning additional credits per semester, while EDP enables an extended timeline with fewer credits per semester," Kumar told PTI.

"Under ADP and EDP, students earn the same total credits as in the standard-duration programme. The higher education institutions will establish committees to evaluate students' eligibility for these programmes. These degrees will be equivalent to standard duration degrees for all employment and academic purposes," he added.

According to the SOPs, the institutions may earmark up to 10 per cent of the sanctioned ntake for ADP. The HEIs may constitute a committee to scrutinize applications received at the end of the first or the second semester under EDP and ADP and select students accordingly. In the ADP, students will follow the same curriculum content and total credts prescribed for the programme for a standard duration.

"The only change will be in the duration of the programme. Students shall have the option to choose ADP either at the end of the first semester or the second semester and not beyond that. Students opting for the ADP will earn additional credits per semester starting from the second or third semester, depending on when they transition to the ADP," Kumar said. "If they join the ADP after the first semester, they will begin earning extra credits from the second semester onward. Similarly, if they join the ADP after the second semester, the additional credit load will start from the third semester onward," he added. In a three-year or four-year undergraduate programme, the duration may be extended up to a maximum of two semesters. "Accordingly, students can earn fewer credits in each semester. Based on the credit structure in the Curriculum and Credit Framework for Undergraduate Programmes, the committee shall decide the minimum number of credits a student must earn in a semester in EDP." he said.

The UGC has noted that the HEIs may issue degrees for students on completion of the programme in the opted duration (shortened or extended duration) and need not wait to complete the standard duration for the award of the formal degree. "For the accelerated and extended degrees, a self-contained note should be added in the degree stating that the academic requirements required in a standard duration have been completed in a shortened or extended duration. "For an ADP of a four-year undergraduate programme, the note should specify that the student completed the academic requirements of a four-year orogramme in six or seven semesters, as the case may be," Kumar said.

The committee constituted by the HEI will evaluate the credit-completing potential of a student based on their performance in the first or the second semester and give its recommendations. The committee shall then recommend a reduction or an increase in the number of courses and total credits per semester, as per the duration opted by the students.

"Under the ADP and EDP, the transcripts should record only the courses the students take in a semester. The examination and evaluation system will remain the same as the programme with a standard duration," Kumar said.

Police attaches properties...

Chief Investigating Officer, was presented before the NIA Special Court, Doda. Earlier, 36 terrorists from Kishtwar operating from PoK/Pakistan were declared absconders by the NIA Court, Doda. Among these, seven terrorists had their properties identied for attachment as part of the legal proceedings

After reviewing the evidence, the Judge NIA Special Court, Doda Sudesh Sharma, ssued attachment orders under Section 83 CrPC vide order No. 757-59/FTC/D/NIA dated November 27, 2024.

Following the directions of the NIA Court, Doda, the SSP Kishtwar formed a special teams, comprising senior officers accompanied by Executive Magistrates to execute the orders. The attached properties have been marked with signboards to notify the general oublic. SC issues notice...

hearing a CBI plea against the September 20, 2022 order of a Jammu trial court that lirected Malik, serving life term in Tihar jail, to be produced before it physically to crossexamine the prosecution witnesses in the kidnapping case of Rubaiya Sayeed, daughter of politician Mufti Mohammad Sayeed. Observing that even Mumbai terror attack convict Ajmal Kasab was given a fair trial, the bench had earlier said that it could order trial to take place inside the jail besides asking the judge to come to the national capital for the proceedings. Mehta had said Malik physically appearing in the Supreme Court had raised security concerns previously.

this stage being involved in the commission of offence punishable with death or imprisonment for life. So, their bail applications stand dismissed accordingly and be made part of the record. Court further observed that before parting, it needs to be brought on record that In-charge Police Post Greater Kailash namely PSI Puneet Sharma along with his team of officials is stated to be present on spot right from the moment the victim party arrived. But he took no action and allowed the accused persons to assemble on spot at the first place and paid no heed to the repeated requests of the victim party which ultimately resulted into the oss of a precious human life. Had this officer performed his official duty and intervened,

the situation might have been altogether different. His conduct all along together with the clear allegations by the complainant party that he was hand in glove with the accused party, lead to one and only inference that he had taken side and was helping the accused party in pursuing their goal. But all these aspects have not been taken care of and investigated by the Investigating agency. So, it is expected and hoped that further investigation into all these aspects is carried out and concluded at the earliest.

Secondly, the accused persons are stated to be business associates and huge amounts have been received on account of the sales. Therefore, it was imperative to examine the mode of payments adopted and go to the trails of that money so as to find out the real beneficiaries. The investigating agency was further required to examine the ITRs of the persons involved but nothing of that sort has been done.

Rattan Dev Singh, who occupies the center stage in all these transactions, has been conveniently cited as witness by believing his cock and bull story. It is inferable from his statement that he has allowed all these benami transactions carried out in his name or he was also a business associate of the accused persons. But these aspects have also not been dealt adequately. Thirdly, the revenue officers/officials, who have issued the extracts of the record without visiting the spot have a crucial role in such crimes. A naked eye view of the Aks Tatimas attached to the sale deeds executed on 22nd April and 6th June 2019, in favour of Reva Gupta for 1 kanal and half marla, Ramesh Singh and Reva Sharma for 3 V marlas each respectively for the land sold out of the same survey number are remarkably different. The physical boundaries of these small portions vis-a-vis the surroundings thereof have also not been given and there is no mention of any road or public lane were existing in the vicinity. Most of the disputes like in the instant case also arise on account of these serious lacunas left out purposely to give a free hand to the landsharks to lay claim over any land. But these aspects have also not been gone into by the investigating agency.

Court further observed that the manner in which the charge sheet has been drafted and the documents are bundled together without proper arrangement, numbering and indexing and some of the papers have been repeated randomly amply reflect that investigation has not been given due seriousness. Such charge sheets increase the work of trial courts manyfold besides, reflecting upon professional capabilities of the investigating agency in heinous offences. In the circumstances, SSP Jammu is directed to look into and get the needful done at the earliest so that a free, fair and impartial trial is ensured.
